6	Session, 2021, as effective September 1, 2021, is reenacted and
7	amended to read as follows:
8	(1) "Abuse" <u>:</u>

24	managing or possessory conservator that does not expose the child

- 1 drug in accordance with Subtitle J, Title 3, Occupations Code, by a
- 2 person licensed under that subtitle.
- 3 (3-a) "Intersex child" means a child who is younger
- 4 than 18 years of age and either:
- 5 (A) has inborn chromosomal, gonadal, genital, or
- 6 endocrine characteristics, or a combination of those
- 7 characteristics, that are not suited to the typical definition of
- 8 male or female or are atypical for the determined sex of the child;
- 9 or
- 10 (B) is considered by a medical professional to
- 11 have inborn chromosomal, gonadal, genital, or endocrine
- 12 characteristics that are ambiguous or atypical for the determined
- 13 sex of the child.
- 14 SECTION 2. The changes in law made by this Act to Section
- 15 261.001, Family Code, do not apply to a person alleged to have
- 16 committed abuse with respect to a child who:
- 17 (1) was born on or before August 31, 2010; and
- 18 (2) before the effective date of this Act, under the
- 19 care of a licensed physician began taking puberty suppressant
- 20 prescription drugs or cross-sex hormones or had any surgery or
- 21 medical procedure performed for the purpose of gender transitioning
- 22 or gender reassignment.
- 23 SECTION 3. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
- 25 provided by Section 39, Article III, Texas Constitution. If this
- 26 Act does not receive the vote necessary for immediate effect, this
- 27 Act takes effect on the 91st day after the last day of the
