## CONCURRENT RESOLUTION

- 1 WHEREAS, Federal law sets the federal minimum wage at \$7.25
- 2 an hour; and
- 3 WHEREAS, The last time Congress raised the federal minimum
- 4 wage was in 2007; that year, the Fair Minimum Wage Act of 2007 was
- 5 passed to gradually raise the federal minimum wage from \$5.15 an
- 6 hour to \$7.25 an hour in 2009; the Act included small business tax
- 7 relief provisions and was signed into law by President George W.
- 8 Bush; and
- 9 WHEREAS, Speaking at a 2006 news conference, President Bush
- 10 said that he supported increasing the federal minimum wage, adding
- 11 that to achieve this and other goals, Congress needed to put aside
- 12 partisan differences and work constructively to address the vital
- 13 issues confronting our nation; and
- 14 WHEREAS, In the 14 years since President Bush signed the last
- 15 federal minimum wage increase into law, the desire for Congress to
- 16 put aside partisan differences and work constructively to raise the
- 17 federal minimum wage has grown stronger in the states; and
- 18 WHEREAS, To account for cost of living increases, 29 states
- 19 have set their minimum wage higher than the federal minimum wage,
- 20 though not at the level of a living wage; 14 states, including
- 21 Texas, have set their minimum wage in line with the federal minimum
- 22 wage; and
- 23 WHEREAS, Supporters of a living wage emphasize that
- 24 increasing the federal minimum wage to \$15 an hour would reduce

- 1 poverty and grow the economy; their review of previous minimum wage
- 2 increases found little or no evidence that raising the minimum wage
- 3 reduces employment; and
- 4 WHEREAS, Demonstrating that paying workers more reduces
- 5 turnover, several companies, including Amazon, Walmart, and
- 6 Target, are now paying many hourly workers at least \$15 an hour; a
- 7 2017 Quinnipiac University poll found that a majority of Americans
- 8 would support a minimum wage of \$15 an hour; and
- 9 WHEREAS, Offering a Texas perspective, noted American
- 10 economist Dr. James K. Galbraith, a professor at The University of
- 11 Texas at Austin, wrote that states such as Texas would benefit from
- 12 raising the federal minimum wage to \$15 an hour because such states
- 13 have too many low-wage workers, too much poverty, and too many
- 14 people who are getting food stamps and other welfare because they
- 15 aren't getting paid enough; and
- 16 WHEREAS, The well-being of this nation depends on a strong
- 17 and vibrant economy, and Congress should heed the advice of experts
- 18 such as Dr. Galbraith and raise the minimum wage; now, therefore,
- 19 be it
- 20 RESOLVED, That the 87th Legislature of the State of Texas,
- 21 1st Called Session, hereby respectfully urge the Congress of the
- 22 United States to raise the federal minimum wage to \$15 an hour; and,
- 23 be it further
- 24 RESOLVED, That the Texas secretary of state forward official
- 25 copies of this resolution to the president of the United States, to
- 26 the president of the Senate and the speaker of the House of
- 27 Representatives of the United States Congress, and to all the

- 1 members of the Texas delegation to Congress with the request that
- 2 this resolution be entered in the Congressional Record as a
- 3 memorial to the Congress of the United States of America.
