- 5 ARTICLE I
- 6 SECTION 1. (a) The members of the Texas House of
- 7 Representatives are elected from the districts described by Article
- 8 II of this Act.
- 9 (b) One member is elected from each district established by
- 10 this Act.
- 11 ARTICLE II
- 12 SECTION 1. The districts for members of the Texas House of
- 13 Representatives are as described by PLANH2176 on the redistricting
- 14 computer system operated by the Texas Legislative Council.
- 15 ARTICLE III
- SECTION 1. In this Act, "tract," "block group," and "block"
- 17 mean the geographic areas identified by those terms on the 2020
- 18 Census TIGER/Line Shapefiles, prepared by the federal Bureau of the
- 19 Census for the Twenty-fourth Decennial Census of the United States,
- 20 enumerated as of April 1, 2020.
- 21 SECTION 2. It is the intent of the legislature that if any
- 22 county, tract, block group, block, or other geographic area has
- 23 erroneously been left out of this Act, a court reviewing this Act
- 24 should include that area in the appropriate district in accordance

- 1 with the intent of the legislature, using any available evidence of
- 2 that intent, including evidence such as that used by the Supreme
- 3 Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W. 749

- 5 SECTION 3. (a) This Act supersedes all previous enactments
- 6 or orders adopting districts for the Texas House of
- 7 Representatives. All previous acts of the legislature adopting
- 8 districts for the Texas House of Representatives are repealed.
- 9 (b) Chapter 2 (S.B. 3), Acts of the 83rd Legislature, 1st
- 10 Called Session, 2013 (Article 195a-13, Vernon's Texas Civil
- 11 Statutes), is repealed.
- 12 SECTION 4. The districts described by Article II of this Act
- 13 apply to the election of the members of the Texas House of
- 14 Representatives beginning with the primary and general elections in
- 15 2022 for members of the 88th Legislature. This Act does not affect
- 16 the membership or districts of the House of Representatives of the
- 17 87th Texas Legislature.
- SECTION 5. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect on the 91st day after the last day of the
- 23 legislative session.
