## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the unlawful restraint of a dog; creating a criminal 3 offense. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Chapter 821, Health and Safety Code, is amended by adding Subchapter E to read as follows: 6 SUBCHAPTER E. UNLAWFUL RESTRAINT OF DOG 7 Sec. 821.101. DEFINITIONS. In this subchapter: 8 9 (1) "Adequate shelter" means a sturdy structure: (A) that provides the dog protection from rain, 10 11 hail, sleet, snow, and subfreezing temperatures; and 12 (B) with dimensions that allow the dog while in 13 the shelter to stand erect, sit, turn around, and lie down in a 14 normal position. (2) "Collar" means a band constructed of nylon, 15 leather, or similar material, specifically designed to be placed 16 around the neck of a dog. 17 18 (3) "Harness" means a set of straps constructed of nylon, leather, or similar material, specifically designed to 19 restrain or control a dog. 20 21 (4) "Owner" means a person who owns or has custody or 22 control of a dog. (5) "Properly fitted" means, with respect to a collar 23 24 or harness, a collar or harness that:

1	(A) is appropriately sized for the dog based on
2	the dog's measurements and body weight;
3	(B) does not choke the dog or impede the dog's
4	normal breathing or swallowing; and
5	(C) is attached around the dog in a manner that
6	prevents the dog from escaping and does not cause pain or injury to
7	the dog.
8	(6) "Restraint" means a chain, rope, tether, leash,
9	cable, or other device that attaches a dog to a stationary object or
10	trolley system.
11	Sec. 821.102. UNLAWFUL RESTRAINT OF DOG; OFFENSE. (a) An
12	owner may not leave a dog outside and unattended by use of a
13	restraint unless the owner provides the dog access to:
14	(1) adequate shelter;
15	(2) an area that allows the dog to avoid standing water
16	and any other substance that could cause harm to the health of a dog
17	subjected to prolonged exposure to the substance, including feces
18	<u>or urine;</u>
19	(3) shade from direct sunlight; and
20	(4) potable water.
21	(b) An owner may not restrain a dog outside and unattended
22	by use of a restraint that:
23	(1) is a chain;
24	(2) has weights attached;
25	(3) is attached to a collar or harness not properly
26	fitted; or
27	(4) causes pain or injury to the dog.

(c) A person commits an offense if the person knowingly 1 violates this section. The restraint of each dog that is in 2 3 violation is a separate offense. 4 (d) An offense under this section is a Class C misdemeanor, 5 except that the offense is a Class B misdemeanor if the person has previously been convicted under this section. 6 7 (e) If conduct constituting an offense under this section also constitutes an offense under any other law, the actor may be 8 prosecuted under this section, the other law, or both. 9 10 Sec. 821.103. EXCEPTIONS. (a) Section 821.102 does not apply to: 11 12 (1) the use of a restraint on a dog in a public camping or recreational area in compliance with the requirements of the 13 public camping or recreational area as defined by a federal, state, 14 15 or local authority or jurisdiction; 16 (2) the use of a restraint on a dog while the owner and 17 dog engage in, or actively train for, an activity conducted under a

18 valid license issued by this state provided the activity is 19 associated with the use or presence of a dog;

20 <u>(3) the use of a restraint on a dog while the owner and</u> 21 <u>dog engage in conduct directly related to the business of</u> 22 <u>shepherding or herding cattle or livestock;</u>

23 (4) the use of a restraint on a dog while the owner and 24 dog engage in conduct directly related to the business of 25 <u>cultivating agricultural products;</u>

26 (5) a dog left unattended in an open-air truck bed only 27 for the time necessary for the owner to complete a temporary task

1	that requires the dog to be left unattended in the truck bed;
2	(6) a dog taken by the owner, or another person with
3	the owner's permission, from the owner's residence or property and
4	restrained by the owner or the person for not longer than the time
5	necessary for the owner to engage in an activity that requires the
6	dog to be temporarily restrained; or
7	(7) a dog restrained while the owner and dog are
8	engaged in, or actively training for, hunting or field trialing.
9	(b) This subchapter does not prohibit a person from walking
10	a dog with a handheld leash.
11	Sec. 821.104. EFFECT OF SUBCHAPTER ON OTHER LAW. This
12	subchapter does not preempt a local regulation relating to the
13	restraint of a dog or affect the authority of a political
14	subdivision to adopt or enforce an ordinance or requirement
15	relating to the restraint of a dog if the regulation, ordinance, or
16	requirement:
17	(1) is compatible with and equal to or more stringent
18	than a requirement prescribed by this subchapter; or
19	(2) relates to an issue not specifically addressed by
20	this subchapter.
21	SECTION 2. Subchapter D, Chapter 821, Health and Safety
22	Code, is repealed.
23	SECTION 3. The change in law made by this Act applies only
24	to an offense committed on or after the effective date of this Act.
25	An offense committed before the effective date of this Act is
26	governed by the law in effect on the date the offense was committed,
27	and the former law is continued in effect for that purpose. For

1 purposes of this section, an offense was committed before the 2 effective date of this Act if any element of the offense occurred 3 before that date.

4 SECTION 4. This Act takes effect on the 91st day after the 5 last day of the legislative session.
