- 1 WHEREAS, Residents of Corpus Christi lost an admired civic
- 2 leader with the passing of Lena D. Wilson on September 8, 2021, at
- 3 the age of 91; and
- WHEREAS, The daughter of Dovie Sutton and Albert Satterwhite,
- 5 the former Lena Delores Satterwhite was born in Gonzales County on
- 6 August 31, 1930; she grew up in Seguin and demonstrated a strong
- 7 work ethic as a young girl, bussing tables at a hotel café and
- 8 holding down a job at a dry cleaners; after graduating from
- 9 Lincoln-Ball High School in 1949, she completed nursing school, but
- 10 she left that field to earn a master's degree in business; she owned
- 11 a popular restaurant and music venue before focusing her career on
- 12 social services; and
- WHEREAS, In 1976, she moved to Corpus Christi, where she
- 14 established herself as an entrepreneur, owning such businesses as
- 15 the Unity Chapel Funeral Home; she married Frank Alfred Wilson and
- 16 devoted herself to their treasured family, including twin daughters
- 17 Lana and Dana and son Al; and
- WHEREAS, Mrs. Wilson became executive director of HIALCO, a
- 19 community service agency, and then director of mental retardation
- 20 vocational services for the Nueces County MHMR Community Center; a
- 21 pioneer in vocational education, she was also instrumental in the
- 22 establishment of two residential homes for people with
- 23 disabilities, Elliott Grant Homes and Jefferine Lytle Estates; she
- 24 eventually launched her own company, Lena's Business Management and

- 1 Consultants, as well as the nonprofit LC Foundation, which helps
- 2 individuals with disabilities find permanent jobs; its initiatives
- 3 have further included creation of the Lena Coleman-Wilson Hope
- 4 Scholarship at Texas A&M University-Corpus Christi, holiday
- 5 donations to children, and contributions to a local group
- 6 alleviating hunger; deeply committed to education, Mrs. Wilson
- 7 also funded the Lena D. Wilson Visionary Legacy Scholarship at
- 8 Lincoln-Ball High School; she was a member of the League of Women
- 9 Voters and president emeritus of the H. Boyd Hall branch of the
- 10 NAACP, and she held leadership roles with such organizations as the
- 11 United Way and the local chamber of commerce; and
- 12 WHEREAS, A woman of faith, Mrs. Wilson attended church
- 13 services regularly; she eventually retired to Schertz, closer to
- 14 her home congregation, New St. James Baptist Church in Seguin; and
- WHEREAS, Lena Wilson gave freely of her time, resources, and
- 16 expertise to better her community, and her contributions will be
- 17 remembered and admired for years to come; now, therefore, be it
- 18 RESOLVED, That the House of Representatives of the 87th Texas
- 19 Legislature, 3rd Called Session, hereby pay tribute to the life of
- 20 Lena D. Wilson and extend sincere sympathy to all who mourn her
- 21 passing; and, be it further
