- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Chapter 42, Code of Criminal Procedure, is
- 7 amended by adding Article 42.01991 to read as follows:
- 8 Art. 42.01991. FINDING REGARDING AGREEMENT ON PAROLE
- 9 ELIGIBILITY FOR CERTAIN DEFENDANTS. (a) This article applies only
- in the trial of an offense under Section 20A.02(a)(5), (6), (7), or
- 11 (8), Penal Code, in which:
- 12 (1) the defendant enters a plea of guilty; and
- 13 (2) the attorney representing the state, the attorney
- 14 representing the defendant, and the defendant agree in writing that
- 15 the defendant will become eligible for release on parole as
- 16 described by Section 508.145(c-1)(2), Government Code.
- 17 (b) In the trial of an offense to which this article
- 18 applies, on the motion of the attorney representing the state, the
- 19 judge shall make an affirmative finding of fact that the parties
- 20 have entered into the agreement described by Subsection (a)(2) and
- 21 shall enter the affirmative finding in the judgment in the case.
- SECTION 2. Section 508.145, Government Code, is amended by
- 23 amending Subsection (a) and adding Subsection (c-1) to read as

- 18 described by Subdivision (1) for which the judgment in the case
- 19 contains an affirmative finding under Article 42.01991, Code of

- 21 <u>inmate's actual calendar time served, without consideration of good</u>
- 22 conduct time, equals one-half of the sentence or 30 calendar years,
- 23 whichever is less, but in no event is the inmate eligible for
- 24 release on parole in less than two calendar years.
