- 3 subject to the sunset review process.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 11.003, Agriculture Code, is amended to
- 6 read as follows:
- 7 Sec. 11.003. SUNSET PROVISION. The Department of
- 8 Agriculture is subject to Chapter 325, Government Code (Texas
- 9 Sunset Act). Unless continued in existence as provided by that
- 10 chapter, the department is abolished September 1, 2023 [2021].
- 11 SECTION 2. Section 74.127(a), Agriculture Code, is amended
- 12 to read as follows:
- 13 (a) The board of directors of the official cotton growers'
- 14 boll weevil eradication foundation is subject to Chapter 325,
- 15 Government Code (Texas Sunset Act). Unless continued in existence
- 16 as provided by that chapter, the board is abolished and this
- 17 subchapter expires September 1, 2023 [2021].
- SECTION 3. Section 161.027, Agriculture Code, is amended to

- SECTION 7. Section 449.002, Government Code, is amended to

- Sec. 449.002. SUNSET PROVISION. The Texas Holocaust and
- 25 Genocide Commission is subject to Chapter 325 (Texas Sunset Act).
- 26 Unless continued in existence as provided by that chapter, the
- 27 commission is abolished and this chapter expires September 1, 2023

- 2 SECTION 8. Section 481.003, Government Code, is amended to

- 7 chapter, the office is abolished and this chapter expires September
- 8 1, 2023 [2021].
- 9 SECTION 9. Section 511.003, Government Code, is amended to

- 11 Sec. 511.003. SUNSET PROVISION. The Commission on Jail
- 12 Standards is subject to Chapter 325 (Texas Sunset Act). Unless
- 13 continued in existence as provided by that chapter, the commission
- 14 is abolished and this chapter expires September 1, 2023 [2021].
- 15 SECTION 10. Section 751.003, Government Code, is amended to
- 16 read as follows:
- 17 Sec. 751.003. SUNSET PROVISION. The Office of
- 18 State-Federal Relations is subject to Chapter 325 (Texas Sunset
- 19 Act). Unless continued in existence as provided by that chapter,
- 20 the office is abolished and this chapter expires September 1, 2023

- SECTION 11. Section 825.006, Government Code, is amended to
- 23 read as follows:
- Sec. 825.006. SUNSET PROVISION. The board of trustees of
- 25 the Teacher Retirement System of Texas is subject to review under
- 26 Chapter 325 (Texas Sunset Act), but is not abolished under that
- 27 chapter. The board shall be reviewed during the period in which

- 2 that year, are reviewed.
- 3 SECTION 12. Section 691.003, Health and Safety Code, is
- 4 amended to read as follows:
- 5 Sec. 691.003. SUNSET PROVISION. The Anatomical Board of
- 6 the State of Texas is subject to Chapter 325, Government Code (Texas
- 7 Sunset Act). Unless continued in existence as provided by that
- 8 chapter, the board is abolished September 1, 2023 [2021].
- 9 SECTION 13. Section 51.002(a), Occupations Code, is amended
- 10 to read as follows:
- 11 (a) The Texas Commission of Licensing and Regulation and the
- 12 Texas Department of Licensing and Regulation are subject to Chapter
- 13 325, Government Code (Texas Sunset Act). Unless continued in
- 14 existence as provided by that chapter, the commission and the
- department are abolished September 1, 2023 [2021].
- 16 SECTION 14. Section 801.003, Occupations Code, is amended
- 17 to read as follows:
- 18 Sec. 801.003. APPLICATION OF SUNSET ACT. The State Board of
- 19 Veterinary Medical Examiners is subject to Chapter 325, Government
- 20 Code (Texas Sunset Act). Unless continued in existence as provided
- 21 by that chapter, the board is abolished and this chapter expires
- 22 September 1, 2023 [2021].
- 23 SECTION 15. Section 1701.002, Occupations Code, is amended
- 24 to read as follows:
- Sec. 1701.002. APPLICATION OF SUNSET ACT. The Texas
- 26 Commission on Law Enforcement is subject to Chapter 325, Government
- 27 Code (Texas Sunset Act). Unless continued in existence as provided

- 2 expires September 1, 2023 [2021].
- 3 SECTION 16. Section 2021.008(a), Occupations Code, is
- 4 amended to read as follows:
- 5 (a) The commission is subject to Chapter 325, Government
- 6 Code (Texas Sunset Act). Unless continued in existence as provided
- 7 by that chapter, and except as provided by Subsections (b) and (c),
- 8 the commission is abolished and this subtitle expires September 1,
- 9 2023 [2021].
- 10 SECTION 17. Section 11.0111, Parks and Wildlife Code, is
- 11 amended to read as follows:
- 12 Sec. 11.0111. SUNSET PROVISION. The Parks and Wildlife
- 13 Department is subject to Chapter 325, Government Code (Texas Sunset
- 14 Act). Unless continued in existence as provided by that chapter,
- 15 the department is abolished September 1, 2023 [2021].
- SECTION 18. Section 8502.0021(a), Special District Local
- 17 Laws Code, is amended to read as follows:
- 18 (a) The authority is subject to review under Chapter 325,
- 19 Government Code (Texas Sunset Act), but may not be abolished under
- 20 that chapter. The review shall be conducted under Section 325.025,
- 21 Government Code, as if the authority were a state agency scheduled
- 22 to be abolished September 1, 2023 [2021], and every 12th year after
- 23 that year.
- 24 SECTION 19. If a conflict exists between this Act and
- 25 another Act of the 87th Legislature, Regular Session, 2021, that
- 26 extends the sunset date of a governmental entity, the provisions of
- 27 the other Act control without regard to the relative dates of

- 1 enactment.
- 2 SECTION 20. This Act takes effect immediately if it
- 3 receives a vote of two-thirds of all the members elected to each
- 4 house, as provided by Section 39, Article III, Texas Constitution.
- 5 If this Act does not receive the vote necessary for immediate
- 6 effect, this Act takes effect September 1, 2021.
