1 AN ACT

- 2 relating to a study on the use of alternative therapies for treating
- 3 post-traumatic stress disorder.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. (a) In this Act, "commission" means the Health
- 6 and Human Services Commission.
- 7 (b) The commission, in collaboration with Baylor College of
- 8 Medicine and in partnership with a military veterans hospital or a
- 9 medical center that provides medical care to veterans, shall
- 10 conduct a study on the efficacy of using alternative therapies,
- 11 including the use of 3,4-methylenedioxymethamphetamine (MDMA),
- 12 psilocybin, and ketamine, in the treatment of veterans who suffer
- 13 from post-traumatic stress disorder.
- 14 (c) In conducting the study described by Subsection (b) of
- 15 this section, the commission in collaboration with the Baylor
- 16 College of Medicine shall:
- 17 (1) perform a clinical trial on the therapeutic
- 18 efficacy of using psilocybin in the treatment of
- 19 treatment-resistant post-traumatic stress disorder in veterans;
- 20 and
- 21 (2) review current literature regarding:
- 22 (A) the safety and efficacy of
- 23 3,4-methylenedioxymethamphetamine (MDMA), psilocybin, and
- 24 ketamine in the treatment of post-traumatic stress disorder; and

- 1 (B) the access veterans have to
- 2 3,4-methylenedioxymethamphetamine (MDMA), psilocybin, and
- 3 ketamine for treatment of post-traumatic stress disorder in the
- 4 United States.
- 5 (d) The commission shall prepare and submit to the governor,
- 6 the lieutenant governor, the speaker of the house of
- 7 representatives, and each member of the legislature:
- 8 (1) quarterly reports on the progress of the study
- 9 conducted under this section; and
- 10 (2) not later than December 1, 2024, a written report
- 11 containing the results of the study conducted under this section
- 12 and any recommendations for legislative or other action.
- 13 (e) The commission shall ensure any protected health
- 14 information collected during a clinical trial conducted under
- 15 Subsection (c) of this section and reported under Subsection (d) of
- 16 this section does not personally identify an individual.
- 17 (f) This Act expires September 1, 2025.
- SECTION 2. The Agency is required to implement this Act only
- 19 if the legislature appropriates money specifically for that
- 20 purpose. If the legislature does not appropriate money
- 21 specifically for that purpose, the commission may, but is not
- 22 required to, implement this Act using other appropriations
- 23 available for the purpose.
- 24 SECTION 3. This Act takes effect immediately if it receives
- 25 a vote of two-thirds of all the members elected to each house, as
- 26 provided by Section 39, Article III, Texas Constitution. If this
- 27 Act does not receive the vote necessary for immediate effect, this

1 Act takes effect September 1, 2021.
