 1-18 AN ACT

1-19 relating to the powers of and election to the board of directors of
 1-20 the Nacogdoches County Hospital District.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Section 1069.051, Special District Local Laws
 1-23 Code, is amended by amending Subsection (b) and adding Subsection
 1-24 (c) to read as follows:

1-25 (b) Directors ~~[Unless four-year terms are established under~~
 1-26 ~~Section 285.081, Health and Safety Code:~~

1-27 ~~[(1) directors]~~ serve staggered four-year ~~[two-year]~~
 1-28 terms.

1-29 (c) An ~~[, and~~
 1-30 ~~[(2) an]~~ election shall be held in each even-numbered
 1-31 year [annually] on the November ~~[May]~~ uniform election date~~[, or~~
 1-32 ~~another date authorized by law,]~~ to elect the appropriate number of
 1-33 directors.

1-34 SECTION 2. Section 1069.209(a), Special District Local Laws
 1-35 Code, is amended to read as follows:

1-36 (a) The board shall select one or more banks inside or
 1-37 outside ~~[in]~~ the district to serve as a depository for district
 1-38 money.

1-39 SECTION 3. (a) At the election of the board of directors of
 1-40 the Nacogdoches County Hospital District scheduled to be held in
 1-41 November 2022, all board member positions will be up for election.
 1-42 The terms of the directors serving immediately before the date of
 1-43 the election expire on the date a majority of the directors elected
 1-44 at the November 2022 election have qualified for office.

1-45 (b) The members of the board of directors elected in
 1-46 November 2022 under Subsection (a) of this section shall draw lots
 1-47 to determine which four directors shall serve four-year terms and
 1-48 which three directors shall serve two-year terms.

1-49 (c) Successor directors shall serve four-year terms.

1-50 SECTION 4. This Act takes effect January 1, 2022.
