## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the authority of the Tarrant County Hospital District
3	or a nonprofit corporation formed by the district regarding certain
4	technology or intellectual property owned by or licensed to the

6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subchapter C, Chapter 281, Health and Safety
8	Code, is amended by adding Section 281.0519 to read as follows:
9	Sec. 281.0519. TARRANT COUNTY HOSPITAL DISTRICT; AUTHORITY
10	TO SELL OR LICENSE INTELLECTUAL PROPERTY. (a) The Tarrant County
11	Hospital District or a nonprofit corporation formed by the district
12	may:
13	(1) sell or license technology or intellectual
14	property that is owned by or licensed to the district or a nonprofit
15	corporation formed by the district;
16	(2) enter into a contract to provide services related
17	to technology or intellectual property sold or licensed under
18	Subdivision (1);
19	(3) contract, collaborate, or enter into a joint
20	venture or other agreement with a public or private entity to engage
21	in an activity authorized under Subdivision (1) or (2); or
22	(4) take any other action necessary to protect or

23 benefit from the exclusivity of technology and intellectual

24 property owned by or licensed to the district or a nonprofit

- 2 acquiring, registering, securing, holding, protecting, and
- 3 renewing under applicable provisions of state, federal, or

- 5 (A) a patent;
- 6 (B) a copyright;
- 7 (C) a trademark, service mark, collective mark,
- 8 or certification mark; or
- 9 (D) any other form of protection of intellectual
- 10 property provided by law.
- 11 (b) For purposes of Subsection (a)(3):
- 12 (1) a public or private entity may be a for-profit or a
- 13 nonprofit entity; and
- 14 (2) a nonprofit corporation formed by the district may
- 15 hold an ownership interest in a public or private entity described
- 16 by Subsection (a)(3).
- 17 (c) Information prepared or compiled by or for the Tarrant
- 18 County Hospital District or a nonprofit corporation formed by the
- 19 district relating to the development of technology or intellectual
- 20 property to which this section applies is exempt from public
- 21 disclosure under Chapter 552, Government Code.
- 22 SECTION 2. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2021.
