Section 11.132(c), Water Code, is amended to read as follows: 6 In the notice, the commission shall: 7 (C) state the name and address of the applicant; 8 (1)9 (2) state the date the application was filed; 10 (3) state the purpose and extent of the proposed appropriation of water; 11 identify the source of supply and the place where 12 (4) the water is to be stored or taken or diverted from the source of 13 14 supply; 15 (5) identify any proposed alternative source of water, other than state water, identified by the applicant; 16 17 (6) specify the time and location where the commission will consider the application; 18 (7) provide the Internet website address of the posted 19 application, map, and supporting materials; and 20 21 <u>(8)</u> [<del>(7)</del>] give any additional information the commission considers necessary. 22 23 SECTION 4.
