- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Article 2.122(a), Code of Criminal Procedure, is
- 7 amended to read as follows:
- 8 (a) The following named criminal investigators of the
- 9 United States shall not be deemed peace officers, but shall have the
- 10 powers of arrest, search, and seizure under the laws of this state
- 11 as to felony offenses only:
- 12 (1) Special Agents of the Federal Bureau of
- 13 Investigation;
- 14 (2) Special Agents of the Secret Service;
- 15 (3) Special Agents of the United States Immigration
- 16 and Customs Enforcement;
- 17 (4) Special Agents of the Bureau of Alcohol, Tobacco,
- 18 Firearms and Explosives;
- 19 (5) Special Agents of the United States Drug
- 20 Enforcement Administration;
- 21 (6) Inspectors of the United States Postal Inspection
- 22 Service;
- 23 (7) Special Agents of the Criminal Investigation
- 24 Division of the Internal Revenue Service;

- 1 (8) Civilian Special Agents of the United States Naval
- 2 Criminal Investigative Service;
- 3 (9) Marshals and Deputy Marshals of the United States
- 4 Marshals Service;
- 5 (10) Special Agents of the United States Department of
- 6 State, Bureau of Diplomatic Security;
- 7 (11) Special Agents of the Treasury Inspector General
- 8 for Tax Administration;
- 9 (12) Special Agents of the Office of Inspector General
- 10 of the United States Social Security Administration;
- 11 (13) Special Agents of the Office of Inspector General
- 12 of the United States Department of Veterans Affairs;
- 13 (14) Special Agents of the Office of Inspector General
- 14 of the United States Department of Agriculture; [and]
- 15 (15) Special Agents of the Office of Export
- 16 Enforcement of the United States Department of Commerce; and
- 17 (16) a police officer with the Office of Security and
- 18 Law Enforcement of the United States Department of Veterans
- 19 Affairs.
- 20 SECTION 2. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2021.
