H.B. No. 3706

A BILL TO BE ENTITLED

1 AN ACT  
2 relating to the state historic sites and parks under the  
3 jurisdiction of the Texas Historical Commission.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 442.072(a), Government Code, is amended  
6 to read as follows:

7 (a) The following historic sites and parks are under the  
8 commission's jurisdiction:

21           SECTION 2. The heading to Section 442.076, Government Code,  
22 is amended to read as follows:

23           Sec. 442.076.   FRENCH LEGATION STATE HISTORIC SITE.

24           SECTION 3. Sections 442.076(a) and (b), Government Code,  
25 are amended to read as follows:

26           (a) The commission is responsible for:

27               (1) the preservation, maintenance, and restoration of

1 the [~~property known as the~~] French Legation State Historic Site  
2 [~~and its contents~~]; and

3 (2) the protection of the historical and architectural  
4 integrity of the building exterior, building interior, and grounds  
5 of the French Legation State Historic Site.

6 (b) Any power or duty related to the French Legation State  
7 Historic Site formerly vested in another state agency or entity is  
8 vested solely in the commission.

9 SECTION 4. Section 442.077, Government Code, is amended to  
10 read as follows:

11 Sec. 442.077. AGREEMENT RELATING TO FRENCH LEGATION STATE  
12 HISTORIC SITE. The commission may enter into an agreement with the  
13 Daughters of the Republic of Texas regarding the management,  
14 staffing, parking facilities, operation, and financial support of  
15 the [~~property known as the~~] French Legation State Historic Site.

16 SECTION 5. The heading to Subchapter G, Chapter 442,  
17 Government Code, is amended to read as follows:

18 SUBCHAPTER G. PORT ISABEL LIGHTHOUSE STATE HISTORIC SITE  
19 [~~HISTORICAL MONUMENT AND PARK~~]

20 SECTION 6. Section 442.271, Government Code, is amended to  
21 read as follows:

22 Sec. 442.271. JURISDICTION. (a) The Port Isabel  
23 Lighthouse State Historic Site is a state historical monument and  
24 park and is under the jurisdiction of the commission.

25 (b) The Port Isabel Lighthouse State Historic Site  
26 [~~Historical Monument and Park~~] is a historic site for purposes of  
27 Subchapter C.

1 SECTION 7. This Act takes effect September 1, 2021.
