A BILL TO BE ENTITLED

AN ACT

relating to middle mile broadband service provided by an electric utility.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Chapter 43, Utilities Code, is amended to read as follows:

CHAPTER 43. PROVISION [USE] OF MIDDLE MILE [ELECTRIC DELIVERY SYSTEM FOR ACCESS TO] BROADBAND SERVICE BY ELECTRIC UTILITIES [AND OTHER ENHANCED SERVICES, INCLUDING COMMUNICATIONS]

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 43.001. LEGISLATIVE FINDINGS. (a) The legislature finds that access to quality, high-speed broadband Internet service is important to this state, is a necessary prerequisite for enabling economic development and improving education, health care, public safety, and government services in this state, and provides other benefits to its citizens [~~broadband over power lines, also known as BPL, is an emerging technology platform that offers a means of providing broadband services to reach homes and businesses. BPL services can also be used to enhance existing electric delivery systems, which can result in improved service and reliability for electric customers~~].

(b) [~~The legislature finds that access to quality, high speed broadband services is important to this state. BPL deployment in Texas has the potential to extend broadband service~~

1 ~~to customers where broadband access is currently not available and~~
2 ~~may provide an additional option for existing broadband consumers~~
3 ~~in Texas, resulting in a more competitive market for broadband~~
4 ~~services.]~~ The legislature [~~further~~] finds that broadband [BPL]
5 development in unserved areas of Texas can be facilitated by [~~is~~
6 ~~fully dependent upon~~] the participation of electric utilities in
7 this state that own and operate [~~power lines and related~~]
8 facilities that may be useful [~~are necessary~~] for the full
9 deployment of broadband service by Internet service providers
10 throughout this state [~~construction of BPL systems and the~~
11 ~~provision of BPL services~~].

12 (c) The legislature finds that electric utilities have
13 existing infrastructure in place throughout this state and that
14 excess fiber capacity on that infrastructure could be used to
15 provide middle mile broadband service in unserved areas.

16 (d) The [~~(c) Consistent with the goal of increasing options~~
17 ~~for telecommunications in this state, the~~] legislature finds that
18 it is in the public interest to encourage the deployment of
19 broadband service in unserved areas [BPL] by permitting electric
20 utilities to own or operate facilities providing middle mile
21 broadband service to lease excess fiber capacity [~~affiliates of the~~
22 ~~electric utility, or permitting unaffiliated entities, to own or~~
23 ~~operate all or a portion of such BPL systems~~]. The purpose of this
24 chapter is to provide the appropriate framework to facilitate the
25 leasing of excess fiber capacity on electric utility facilities
26 [~~support the deployment of BPL~~].

27 (e) [(d)] The legislature finds that an electric utility

1 may choose to implement middle mile broadband service to lease
2 excess fiber capacity to Internet service providers [BPL] under the
3 procedures set forth in this chapter, but is not required to do so.
4 The electric utility shall have the right to decide, in its sole
5 discretion, whether to implement middle mile broadband service
6 [BPL] and may not be penalized for deciding to implement or not to
7 implement that service [BPL].

8 Sec. 43.002. APPLICABILITY. (a) This chapter applies to an
9 electric utility whether or not the electric utility is offering
10 customer choice under Chapter 39.

11 (b) If there is a conflict between the specific provisions
12 of this chapter and any other provisions of this title, the
13 provisions of this chapter control.

14 (c) Except as otherwise provided by this title, no [No]
15 provision of this title imposes [~~shall impose~~] an obligation on an
16 electric utility to construct or operate a middle mile system, to
17 [~~implement BPL, to~~] provide middle mile broadband service
18 [~~services~~], or to allow others to install [BPL] facilities or use
19 the electric utility's facilities for the provision of broadband
20 service [~~services~~].

21 Sec. 43.003. DEFINITIONS. In this chapter:

22 (1) "Broadband service" means retail Internet service
23 provided by a commercial Internet service provider with the
24 capability of providing a download speed of 25 megabits per second
25 or faster and an upload speed of 3 megabits per second or faster
26 [~~"BPL," "broadband over power lines," and "BPL services" mean the~~
27 ~~provision of broadband services over electric power lines and~~

1 ~~related facilities, whether above ground or in underground~~
2 ~~conduit].~~

3 (2) "Middle mile broadband service" means the
4 provision of excess fiber capacity on an electric utility's
5 electric delivery system to an Internet service provider to provide
6 broadband service. The term does not include provision of Internet
7 service to end-use customers on a retail basis [~~"BPL access" means~~
8 ~~the ability to access broadband services via a BPL operator or BPL~~
9 ~~Internet service provider].~~

10 (3) "Internet [~~"BPL operator" means an entity that~~
11 ~~owns or operates a BPL system on the electric power lines and~~
12 ~~related facilities of an electric utility.~~

13 [~~(4) "BPL Internet~~] service provider" means a
14 commercial [~~and "BPL ISP" mean an~~] entity that provides Internet
15 services [~~to others on a wholesale basis or~~] to end-use customers on
16 a retail basis.

17 (4) [~~(5) "BPL system" means the materials, equipment,~~
18 ~~and other facilities installed on electric utility property to~~
19 ~~facilitate the provision of BPL services.~~

20 [~~(6) "BPL electric utility applications" means~~
21 ~~services and technologies that are used and useful and designed to~~
22 ~~improve the operational performance and service reliability of an~~
23 ~~electric utility including, but not limited to, automated meter~~
24 ~~reading, real time system monitoring and meter control, remote~~
25 ~~service control, outage detection and restoration, predictive~~
26 ~~maintenance and diagnostics, and monitoring and enhancement of~~

1 ~~[(7)]~~ "Electric delivery system" means the power lines
2 and related transmission and distribution facilities constructed
3 ~~[used by an electric utility]~~ to deliver electric energy to the

6 an electric utility and a transmission and distribution utility as
7 defined in Section 31.002(6) or (19).

8 SUBCHAPTER B. DEVELOPMENT OF MIDDLE MILE BROADBAND ~~[BPL]~~ SYSTEMS

9 Sec. 43.051. AUTHORIZATION FOR MIDDLE MILE BROADBAND ~~[BPL]~~
10 SYSTEM. (a) An ~~[affiliate of an]~~ electric utility ~~[or a person~~
11 ~~unaffiliated with an electric utility]~~ may own, construct,
12 maintain, and operate fiber optic cables and other facilities for
13 providing middle mile broadband service ~~[a BPL system and provide~~
14 ~~BPL services on an electric utility's electric delivery system]~~
15 consistent with the requirements of this chapter. Nothing in this
16 chapter prohibits ~~[shall prohibit]~~ an entity defined in Section
17 11.003(9) from providing broadband ~~[BPL]~~ service to an Internet
18 service provider or owning and operating a broadband ~~[BPL]~~ system
19 as otherwise permitted by law.

20 (b) The electric utility may determine on a
21 nondiscriminatory basis which Internet service providers may have
22 access to excess fiber capacity on the electric utility's electric
23 delivery system and provide access points to allow connection
24 between the electric utility's electric delivery system and the
25 Internet service provider systems of those Internet service
26 providers. The electric utility may provide access to excess fiber
27 capacity on the electric utility's middle mile broadband system

1 only on reasonable and nondiscriminatory terms and conditions.

22 ~~[allows an affiliate or an unaffiliated entity to own a BPL system~~
23 ~~on the electric utility's electric delivery system]~~ shall charge

26 associated with that use. The rates, terms, and conditions of a

26 CONSIDERATION REQUIRED. (a) Because broadband [~~BPL~~] systems
27 provide benefits to electric delivery systems, the installation of

1 a middle mile broadband [~~BPL~~] system on an electric delivery system
2 does [~~shall~~] not require the electric utility [~~or the owner of the~~
3 ~~BPL system~~] or an entity defined in Section 11.003(9) to obtain,
4 modify, or expand easements or other rights-of-way for the middle
5 mile broadband [~~BPL~~] system or to give additional consideration as
6 a result of the installation or the operation of a middle mile

19 on the most recent tax roll of each county authorized to levy
20 property taxes against the property; and

21 (2) state whether any new fiber optic cables used for
22 middle mile broadband service will be located above or below ground
23 in the easement or other property right.

24 (d) Not later than the 60th day after the date an electric
25 utility mails notice under this section, a property owner entitled
26 to the notice may submit to the electric utility a written protest
27 of the intended use of the easement or other property right for

1 middle mile broadband service. An electric utility that receives a
2 timely written protest may not use the easement or other property
3 right for middle mile broadband service unless the protestor later
4 agrees in writing to that use or that use is authorized by law. If a
5 property owner fails to submit a timely written protest, an
6 electric utility may proceed under Subsection (a) without modifying
7 or expanding the easement for that property owner.

8 (e) An electric utility that receives a timely written
9 protest under Subsection (d) regarding a proposed middle mile
10 broadband project may cancel the project at any time.

11 (f) The requirements of this section do not apply to an
12 existing easement that permits the installation of a third-party
13 middle mile broadband system on an electric delivery system. [~~For~~
14 purposes of this section, installation of a BPL system shall be
15 deemed to be consistent with installation of an electric delivery
16 system.]

17 Sec. 43.054 [~~43.055~~]. RELIABILITY OF ELECTRIC SYSTEMS
18 MAINTAINED. An electric utility that installs [~~allows the~~
19 ~~installation~~] and operates [~~operation of~~] a middle mile broadband
20 [~~BPL~~] system [~~on its electric delivery system~~] shall employ all
21 reasonable measures to ensure that the operation of the middle mile
22 broadband [~~BPL~~] system does not interfere with or diminish the
23 reliability of the utility's electric delivery system. If [~~Should~~]
24 a disruption in the provision of electric service occurs [~~occur~~],
25 the electric utility is [~~shall be~~] governed by the terms and
26 conditions of the retail electric delivery service tariff. The
27 electric utility may take all necessary actions regarding its

2 that may pose health, safety, or reliability concerns. At all
3 times, the provision of broadband service is [~~services shall be~~]

6 Internet service provider, for any direct, indirect, or
7 consequential damages, including loss of business, loss of profits
8 or revenue, or loss of production capacity caused by a fluctuation,
9 disruption, or interruption of middle mile broadband service that
10 is caused in whole or in part by:

- 11 (1) force majeure; or
12 (2) the electric utility's provision of electric
13 delivery services, including actions taken by the electric utility
14 to ensure the reliability of the electric delivery system and
15 actions taken in response to address emergency circumstances that
16 may pose health, safety, or reliability concerns.

17 SUBCHAPTER C. IMPLEMENTATION OF MIDDLE MILE BROADBAND [~~BPL~~] SYSTEM
18 BY ELECTRIC UTILITY

19 Sec. 43.101. PARTICIPATION BY ELECTRIC UTILITY. (a) An
20 electric utility[~~, through an affiliate or through an unaffiliated~~
21 ~~entity,~~] may [~~elect to~~] install and operate a middle mile broadband
22 [~~BPL~~] system on any part of its electric delivery system for
23 Internet service providers but may not construct new electric
24 delivery facilities for the purpose of the electric utility's
25 middle mile service [~~some or all of its electric delivery system in~~
26 ~~any part or all of its certificated service area~~].

27 (b) The installation, operation, and use of a middle mile

1 broadband [BPL] system and the provision of middle mile broadband
2 service and the lease of excess fiber capacity by Internet service

4 regulated by any state agency, a municipality, or local government

20 (a) An electric utility that plans a project to deploy middle mile
21 broadband shall submit to the commission a written plan that
22 includes:

23 (1) the route of the middle mile broadband
24 infrastructure proposed for the project;

25 (2) the number of fiber strands and any other
26 facilities that would be used in connection with the project and
27 dedicated to an Internet service provider;

1 (3) the location of the electric utility's
2 infrastructure that will be used in connection with the project;

3 (4) the capacity or number of fiber strands and any
4 other facilities of the middle mile that will be available to lease
5 to Internet service providers and other third parties on completion
6 of the project;

7 (5) the name of at least one Internet service provider
8 that has committed to leasing access to the middle mile broadband
9 assets constructed as part of the project;

10 (6) an estimate of potential broadband customers that
11 would be served by the Internet service provider;

12 (7) the estimated cost of the project, including
13 engineering costs, construction costs, permitting costs,
14 right-of-way costs, and a reasonable allowance for funds used
15 during construction;

16 (8) the proposed schedule of construction for the
17 project;

18 (9) the method of attachment and connection of the
19 middle mile broadband assets by the Internet service provider to
20 the electric utility's electric delivery system;

21 (10) testimony, exhibits, or other evidence that
22 demonstrates the project will allow for the provision and
23 maintenance of adequate, efficient, safe, reliable, and reasonably
24 priced middle mile broadband service; and

25 (11) any other information that the applicant
26 considers relevant or that the commission requires.

27 (b) The commission, after notice and hearing if required by

1 the commission, shall approve the plan if the commission finds that
2 the plan will allow for the provision and maintenance of adequate,
3 efficient, safe, reliable, and reasonably priced middle mile
4 broadband service.

5 (c) The commission must approve, modify, or reject a plan
6 submitted to the commission under this section not later than the
7 181st day after the date the plan is submitted under Subsection (a).

8 (d) An approved plan may be updated or amended subject to
9 commission approval in accordance with this section.

10 Sec. 43.103 [~~43.102~~]. COST RECOVERY FOR DEPLOYMENT OF
11 MIDDLE MILE BROADBAND FACILITIES [~~BPL AND UTILITY APPLICATIONS~~].

12 (a) Where an electric utility installs a middle mile broadband
13 system [~~permits the installation of a BPL system on its electric~~
14 ~~delivery system~~] under Section 43.051 [~~43.052(a)~~], the electric
15 utility's investment in that middle mile broadband [~~BPL~~] system is
16 [~~to directly support the BPL electric utility applications and~~
17 ~~other BPL services consumed by the electric utility that are used~~

14 Sec. 43.151. [~~AFFILIATES OF ELECTRIC UTILITY. (a) Subject~~

16 ~~full or partial ownership interest in a BPL operator or a BPL~~
17 ~~ISP. Whether a BPL operator or a BPL ISP is an affiliate of the~~
18 ~~electric utility shall be determined under Section 11.003(2) or~~
19 ~~Section 11.006.~~

20 [~~(b) Neither a BPL operator nor a BPL ISP shall be~~
21 ~~considered a "competitive affiliate" of an electric utility as that~~
22 ~~term is defined in Section 39.157.~~

23 [~~Sec. 43.152.~~] COMPLIANCE WITH FEDERAL LAW. An electric
24 utility that owns and operates a middle mile broadband system [~~BPL~~
25 ~~operators]~~ shall comply with all applicable federal laws[~~7~~
26 ~~including those protecting licensed spectrum users from~~
27 ~~interference by BPL systems. The operator of a radio frequency~~

1 ~~device shall be required to cease operating the device upon~~
2 ~~notification by a Federal Communications Commission or Public~~
3 ~~Utilities Commission representative that the device is causing~~
4 ~~harmful interference. Operation shall not resume until the~~
5 ~~condition causing the harmful interference has been corrected].~~

6 SECTION 2. Section 33.001(b), Utilities Code, is repealed.

7 SECTION 3. This Act takes effect immediately if it receives
8 a vote of two-thirds of all the members elected to each house, as
9 provided by Section 39, Article III, Texas Constitution. If this
10 Act does not receive the vote necessary for immediate effect, this
11 Act takes effect September 1, 2021.
