- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. STUDY AND ANALYSIS OF PROJECT DELIVERY METHODS.
- 7 (a) The comptroller of public accounts, in conjunction with the
- 8 Texas Department of Transportation and the Texas Water Development
- 9 Board, shall conduct a study on the economic impact and feasibility
- 10 of public-private partnerships as an alternative delivery method
- 11 for certain projects of the department and board.
- 12 (b) In conducting the study, the comptroller shall analyze
- 13 each project submitted under Subsection (c) of this section and
- 14 determine for each project:
- 15 (1) the feasibility of using an alternative project
- 16 delivery method, including the use of private financing;
- 17 (2) the estimated savings to this state if the project
- 18 used an alternative project delivery method, including private
- 19 financing;
- 20 (3) the estimated amount of local money necessary to
- 21 construct or complete the project using traditional project
- 22 delivery methods compared to the money necessary for the project
- 23 using an alternative project delivery method, including private
- 24 financing; and

- 1 (4) the amount of additional money available to other
- 2 regions of this state if the project used an alternative project
- 3 delivery method, including private financing.
- 4 (c) Not later than December 31, 2021:
- 5 (1) the Texas Department of Transportation shall
- 6 conduct a comprehensive review of all proposed road projects with a
- 7 project value of more than \$1 billion and submit a report of those
- 8 projects to the comptroller for analysis under Subsection (b) of
- 9 this section; and
- 10 (2) the Texas Water Development Board shall conduct a
- 11 comprehensive review of all projects in the state water plan with an
- 12 estimated project value of more than \$1 billion and submit a report
- 13 of those projects to the comptroller for analysis under Subsection
- 14 (b) of this section.
- 15 SECTION 2. REPORT TO THE LEGISLATURE. Not later than
- 16 September 1, 2022, the comptroller of public accounts shall submit
- 17 to the governor, the lieutenant governor, the speaker of the house
- 18 of representatives, and the presiding officer of each standing
- 19 committee of the legislature with jurisdiction over transportation
- 20 and water matters a report on the results of the study and analysis
- 21 conducted under Section 1 of this Act and any recommendations of the
- 22 comptroller relating to the study, including any statutory changes
- 23 necessary.
- SECTION 3. EXPIRATION. This Act expires September 1, 2023.
- 25 SECTION 4. EFFECTIVE DATE. This Act takes effect September
- 26 1, 2021.
