CONCURRENT RESOLUTION

1 WHEREAS, U.S. Immigration and Customs Enforcement has

2 strayed far from its original mission, gaining a disturbing

3 reputation as a mass-deportation strike force incompatible with

4 democracy and human rights; and

5 WHEREAS, In the aftermath of the 9/11 attacks against our

nation, ICE was established to promote national security by

7 preventing "acts of terrorism by targeting the people, money, and

8 materials that support terrorist and criminal activities"; the

9 agency grew wildly in subsequent years, losing its focus as its

10 budget ballooned with multimillion dollar contracts for private

11 companies backed by swarms of lobbyists; and

12 WHEREAS, Today, some 8,000 ICE agents are tasked with

13 locating, arresting, detaining, and removing undocumented

immigrants; only about 6,000 are involved in tracking the

15 terrorists and transnational crime syndicates that present a grave

16 peril to the nation and its people; these agents in ICE's Homeland

17 Security Investigations division combat money laundering, drug

18 trafficking, human smuggling, child exploitation, and cybercrimes;

19 in counter-proliferation operations, they target individuals

20 attempting to smuggle military and high-tech equipment out of the

21 country; HSI has also been involved in such complex, high-profile

22 cases as the takedown of the nefarious Silk Road website and the

23 arrest and capture of Sinaloa cartel leader Joaquín "El Chapo"

24 Guzmán Loera; and

WHEREAS, In June 2018, 19 special agents in charge of 1 regional HSI offices submitted a letter to the secretary of 2 Homeland Security requesting that their division be spun off from 3 ICE, stating that their work has been undermined by ICE's 4 5 controversial detention and deportation policies; they cited a breakdown in partnerships with local law enforcement officials, who 6 question the independence of their agency in light of aggressive 7 8 measures against immigration; such actions include targeting families at churches and schools, conducting massive raids, 9 arresting undocumented workers for minor offenses, and breaking up 10 families by sending longtime U.S. residents to countries they 11 12 hardly know; and WHEREAS, While resources are directed away from agents 13 14 to national security, ICE exercises 15 surveillance of communities of color and immigrant communities; moreover, its draconian detention policies have filled the coffers 16 17 of companies that run for-profit facilities with a long, troubling lax oversight, unsafe conditions, and grotesque 18 history of mistreatment, as documented by the DHS Office of Inspector General; 19 in the 2019 fiscal year alone, ICE detained more than 510,000 20 21 immigrants, 81 percent of whom were held in such private facilities, costing taxpayers millions of dollars; and 22 WHEREAS, Before the creation of ICE, immigration violations 23 24 were handled by the Immigration and Naturalization Service, which was part of the Department of Justice and worked closely with the 25 Department of Labor; the inclusion of these functions under ICE has 26

led to the deprioritization of transnational crime fighting while

- 1 framing immigration, historically an engine of economic
- 2 development and societal enrichment, as a national security threat;
- 3 ICE has become a bloated agency tainted by controversy and largely
- 4 unmoored from its original purpose, and the responsible path
- 5 forward is to transfer its critical national security functions and
- 6 develop a more humane and effective immigration system that
- 7 complies with constitutional protections, domestic law, and
- 8 binding international treaties; now, therefore, be it
- 9 RESOLVED, That the 87th Legislature of the State of Texas
- 10 hereby respectfully urge the United States Congress to abolish U.S.
- 11 Immigration and Customs Enforcement; and, be it further
- 12 RESOLVED, That the Texas secretary of state forward official
- 13 copies of this resolution to the president of the United States, to
- 14 the president of the Senate and the speaker of the House of
- 15 Representatives of the United States Congress, and to all the
- 16 members of the Texas delegation to Congress with the request that
- 17 this resolution be entered in the Congressional Record as a
- 18 memorial to the Congress of the United States of America.
