RESOLUTION

- 1 WHEREAS, The longstanding bonds of friendship between the
- 2 United States and Taiwan, embodied in the Taiwan Relations Act of
- 3 1979, continue to yield important economic, strategic, and cultural
- 4 benefits; and
- 5 WHEREAS, Taiwan ranks as the United States' 10th largest
- 6 trading partner, and in 2019, bilateral trade in goods reached
- 7 \$85.5 billion; the seventh-largest export market for
- 8 U.S. agricultural products, Taiwan's biennial agricultural trade
- 9 goodwill missions result in multibillion-dollar supply deals, and
- 10 its annually dispatched delegations to the SelectUSA Investment
- 11 Summit boost investment; Taiwan's recent action to lift
- 12 restrictions on U.S. beef and pork beginning in January 2021 will
- 13 help enhance bilateral trade; and
- 14 WHEREAS, The robust US-Taiwan trade and investment
- 15 partnership provides a solid foundation for a mutually beneficial
- 16 bilateral trade agreement (BTA) to spur job creation, further
- 17 expand the global market, and secure international supply chains;
- 18 Taiwan is well positioned to play an important role in augmenting
- 19 the revitalization of the global supply chain as part of the
- 20 post-pandemic economic recovery; and
- 21 WHEREAS, Taiwan is committed to helping address global
- 22 challenges, from humanitarian crises to nontraditional security
- 23 threats; moreover, this year it has emerged as an important partner
- 24 in pandemic prevention, providing 54 million surgical masks and

- 1 other PPE to more than 80 countries around the world, including
- 2 nearly 1 million surgical masks from the Taiwan government and
- 3 Taiwan affiliated private groups to the State and cities of Texas;
- 4 the Taiwan Model has achieved world renown for its effective
- 5 pandemic prevention and containment, bolstering unprecedented
- 6 international support for Taiwan's bid to participate in the World
- 7 Health Assembly (WHA); and
- 8 WHEREAS, Taiwanese officials and civil society groups
- 9 partner with the United States on a range of issues to promote our
- 10 common values of freedom, democracy, and human rights; in March,
- 11 Taiwan joined with the United States to establish the Partnership
- 12 against Coronavirus, building on the cooperative tradition of prior
- 13 joint partnerships such as the Global Cooperation and Training
- 14 Framework (GCTF), which advances Taiwanese leadership in such
- 15 arenas as democratization, human rights, women's empowerment, and
- 16 public health; and
- 17 WHEREAS, Since 1988, Texas and Taiwan have maintained a
- 18 sister-state relationship, and they enjoy particularly close
- 19 economic ties; Taiwanese firms have invested billions of dollars in
- 20 a wide range of Texas businesses; Taiwan is Texas' 10th largest
- 21 foreign market, and in 2019, it imported nearly \$8.47 billion in
- 22 commodities from Texas, including computers and electronics,
- 23 industrial machinery equipment, chemicals, and foodstuffs; in
- 24 turn, Texas imported over \$3.66 billion in Taiwanese goods,
- 25 primarily computers, electronics, metal products, transportation
- 26 equipment, and industrial machinery; and
- 27 WHEREAS, The establishment of a Texas Trade and Investment

- 1 Office in Taiwan could enhance the participation of small- and
- 2 medium-sized enterprises in trade and investment, and advance the
- 3 sister-state tie between Texas and Taiwan; and
- 4 WHEREAS, Texas and the United States have benefited
- 5 immeasurably through decades of unwavering friendship with Taiwan,
- 6 and the wider world is sure to reap tremendous rewards as Taiwan
- 7 works to enhance its presence in the international community; now,
- 8 therefore, be it
- 9 RESOLVED, That the House of Representatives of the 87th Texas
- 10 Legislature hereby express its support for the strengthening of our
- 11 partnership with Taiwan and for the expansion of Taiwan's role on
- 12 the global stage; and, be it further
- 13 RESOLVED, That the House of Representatives hereby:
- 14 (a) express support for a bilateral trade agreement between
- 15 the United States and Taiwan;
- 16 (b) express support for Taiwan's meaningful participation
- 17 in the International Criminal Police Organization, the
- 18 International Civil Aviation Organization, the United Nations
- 19 Framework Convention on Climate Change, and the World Health
- 20 Assembly;
- 21 (c) express support for a Texas Trade and Investment Office
- 22 in Taiwan; and
- 23 (d) celebrate the 42nd anniversary of the enactment of the
- 24 Taiwan Relations Act and the 33rd anniversary of the sister-state
- 25 relationship between the State of Texas and Taiwan; and, be it
