1 WHEREAS, A rich and purposeful life drew to a close with the
2 passing of Eduardo R. Sanchez of San Antonio on July 21, 2020, at
3 the age of 62; and

4 WHEREAS, The son of Rodolfo and Otilia Sanchez, Eddie Sanchez
5 was born on September 30, 1957, and he grew up with the
6 companionship of six siblings, Frank, Elia, Christina, Aurora,
7 Marcelino, and Estella; and

8 WHEREAS, Mr. Sanchez enjoyed a rewarding career with Riata
9 and Cavender Cadillac that spanned nearly four and a half decades;
10 highly engaged in his community, he was a member of the San Antonio
11 Stock Show and Rodeo for more than 27 years, including 9 years as a
12 director, and he served on the livestock and souvenir committees;

14 WHEREAS, A man of deep faith, Mr. Sanchez gave generously of
15 his time and talents to a number of religious organizations; for
16 over a quarter century, he served Blessed Sacrament Church and
17 School by helping with the Halloween Carnival, church choir,
18 Catholic Youth Organization, and various events; he was also
19 involved in ACTS Retreats for 19 years and the Knights of Columbus
20 Blessed Sacrament Council No. 7016 for 16 years, during which time
21 he held multiple officer positions and reached the rank of
22 fourth-degree Knight; in addition, he was a member of the
23 International Order of Alhambra; and

24 WHEREAS, Above all else, Mr. Sanchez treasured time spent

1 with his family and friends; he shared a fulfilling marriage of
2 three and a half decades with his wife, Elaine, and he was the
3 devoted father of two children, Courtney and Alec; with the passing
4 years, he was further blessed with a granddaughter, Emersyn; in his
5 leisure hours, he delighted in life's simple pleasures, such as
6 listening to music and dancing; and

7 WHEREAS, Eddie Sanchez was a man of great compassion who
8 found joy and inspiration in helping others, and he leaves behind a
9 record of service that his loved ones can remember with pride; now,
10 therefore, be it

11 RESOLVED, That the House of Representatives of the 87th Texas
12 Legislature hereby pay tribute to the life of Eduardo R. Sanchez and
13 extend sincere sympathy to the members of his family and to his many
14 friends; and, be it further
