12 WHEREAS, Mr. Hood enjoyed a rewarding career as a South Texas 13 sales representative with the Colgate-Palmolive Company that 14 spanned 36 years until his retirement in 1989; among his many 15 achievements, he was inducted into the company's Hall of Fame in New 16 York City; and

WHEREAS, Highly dedicated to his community, Mr. Hood was a 17 longtime member of the Leakey Lions Club, a Boy Scout troop leader, 18 a coach for local youth baseball teams, and a cast member of the 19 20 Frio Canyon Players; he also gave generously of his time and talents 21 to the Frio Canyon Parks Association, the Big Springs Auxiliary for Children, and the Big Springs Youth Ranch Thrift Store; a man of 22 23 deep faith, he was a valued congregant of Leakey United Methodist 24 Church; and
