1           WHEREAS, Dewey Douglas Stockbridge of Alpine, a respected  
2 biologist for the Texas Parks and Wildlife Department, tragically  
3 passed away on August 8, 2020, at the age of 36; and

4           WHEREAS, Dewey Stockbridge was born in Fredericksburg on  
5 November 16, 1983, to Randy and Connie Stockbridge and was raised  
6 with a sister, Leslie; he was an outstanding student and athlete at  
7 Mason High School, where he graduated in 2002, and he went on to  
8 obtain a wildlife and fisheries sciences degree at Texas A&M  
9 University in 2006; and

10           WHEREAS, Embarking on his career with the Texas Parks and  
11 Wildlife Department in 2005, Mr. Stockbridge joined the Black Gap  
12 Wildlife Management Area as a wildlife technician; passionate about  
13 habitat restoration for the desert bighorn sheep of far West Texas,  
14 he became deeply engaged in conservation efforts for the animals  
15 and was promoted to wildlife biologist; eventually, he took on the  
16 role of lead wildlife biologist for the Elephant Mountain Wildlife  
17 Management Area, helping to return pronghorn and desert bighorn  
18 sheep to their native range in the Trans-Pecos region; and

19           WHEREAS, Mr. Stockbridge contributed to his professional  
20 community as a member of the Texas Wildlife Association, the Texas  
21 Bighorn Society, the Desert Bighorn Council, and the Wild Sheep and  
22 Mule Deer Foundations, among numerous other organizations; and

23           WHEREAS, In all his endeavors, Mr. Stockbridge enjoyed the  
24 love and support of his wife, the former Shannon Staudt, and their

1 children, Jameson and London; an avid hunter and angler, he passed  
2 on his love of nature and the outdoors to his son and daughter; he  
3 was also a valued member of the First United Methodist Church of  
4 Mason; and

5 WHEREAS, Dewey Stockbridge was a significant asset to his  
6 community and to the Texas Parks and Wildlife Department, and his  
7 commitment to conservation and wildlife restoration will be  
8 remembered and admired for years to come; now, therefore, be it

9 RESOLVED, That the House of Representatives of the 87th Texas  
10 Legislature hereby pay tribute to the life of Dewey Douglas  
11 Stockbridge and extend sincere condolences to the members of his  
12 family: to his wife, Shannon Stockbridge; to his son, Jameson  
13 Stockbridge; to his daughter, London Stockbridge; to his parents,  
14 Randy and Connie Stockbridge; to his sister, Leslie Becker, and her  
15 husband, Travis; to his niece, Aubrey Joy Becker; to his father- and  
16 mother-in-law, Eddie and Peggy Staudt; and to his many other  
17 relatives, friends, and colleagues; and, be it further

18 RESOLVED, That an official copy of this resolution be
