1 WHEREAS, Words cannot adequately express the sorrow felt at
2 the loss of U.S. Navy Midshipman Duke Anthony Carrillo, who died on
3 February 8, 2020, at the age of 21, while attending the U.S. Naval
4 Academy at Annapolis, Maryland; and

5 WHEREAS, The son of Jennifer and Gerald Carrillo, Duke
6 Carrillo was born in San Antonio on October 2, 1998, and grew up in
7 Flower Mound with his twin brother, Dylan, and his younger brother,
8 Jake; he achieved the rank of Eagle Scout at the age of 14, and at
9 Flower Mound High School he was a three-year varsity letterman in
10 football and wrestling, serving as captain of both teams and
11 placing third in the state wrestling championship in his senior
12 year; after graduating from high school in 2017, he attended the
13 Naval Academy Preparatory School in Rhode Island for a year before
14 he and his brother Dylan together joined the Class of 2022 at the
15 Naval Academy; his brother Jake followed a year later, joining the
16 Class of 2023; and

17 WHEREAS, At Annapolis, Midshipman Carrillo was majoring in
18 quantitative economics, and he had earned a 4.0 grade average
19 during his last semester; he served as a Naval Academy Summer
20 Seminar squad leader during the summer of 2019, and as a member of
21 the academy's Flight Training Squadron, he aspired to be a naval
22 aviator; and

23 WHEREAS, High-spirited and hard-working, Midshipman Carrillo
24 delighted in the times he spent with his brothers and his friends;

1 he was a proud Texan who enjoyed fishing, hunting, shooting, and
2 archery, and he was a true fan of Texas Red Dirt music; he was buried
3 with military honors at Annapolis, and his loved ones have created a
4 foundation in his memory; and

5 WHEREAS, Deeply devoted to his family, his country, and his
6 friends, Duke Carrillo will forever be remembered by all who knew
7 him as a generous, energetic, and fiercely loyal young man who gave
8 everything he had to everything he did; now, therefore, be it

9 RESOLVED, That the House of Representatives of the 87th Texas
10 Legislature hereby pay tribute to the life of Midshipman Duke
11 Anthony Carrillo and extend heartfelt sympathy to his family and
12 many friends; and, be it further

13 RESOLVED, That an official copy of this resolution be
14 prepared for his family and that when the Texas House of
15 Representatives adjourns this day, it do so in memory of Midshipman
16 Duke Carrillo.
