1 WHEREAS, Memories of a life filled with joyful times and
2 meaningful accomplishments remain to comfort the family and friends
3 of Carroll Homer Maxwell Jr. of McKinney, who passed away on
4 December 26, 2020, at the age of 92; and

5 WHEREAS, The son of Carroll and Virginia Maxwell, Carroll
6 Maxwell was born in Wichita Falls on May 29, 1928; he moved with his
7 family to Dallas, where he graduated from Highland Park High
8 School, and continued his education at Texas A&M University; and

9 WHEREAS, Mr. Maxwell enjoyed entrepreneurial success over
10 the course of his career; early on, he developed apartments and
11 homes in Richardson, and he and his brother, Jim Maxwell, shared in
12 the operation of several businesses, including a transistor radio
13 factory, TV station channel 33, and Central Systems; and

14 WHEREAS, A valued member of the Republican Party, Mr. Maxwell
15 served as president of the Collin County Conservative Republicans
16 and as a delegate to the 2016 Republican National Convention; he
17 received a Leadership Award from the CCCR and a Conservative
18 Leaders Award from Empower Texans, and he was named Man of the Year
19 by the Golden Corridor Republican Women; and

20 WHEREAS, Mr. Maxwell also lent his support to the CASA
21 organization, and he was honored as Child Advocate of the Year by
22 CASA of Collin County; in addition, he was recognized as Kiwanian of
23 the Year by the Kiwanis Club of McKinney, and he was a longtime
24 member of the First United Methodist Church of McKinney; and

1 WHEREAS, Above all, Mr. Maxwell cherished time spent with his
2 family, which included his wife, the late Marilyn Maxwell, and his
3 children, Alice, Max, Karen, Cathy, and Patty, as well as his 15
4 grandchildren and 2 great-grandchildren; and

5 WHEREAS, Deeply devoted to his family, his faith, and his
6 community, Carroll Maxwell led a life that was rich in personal and
7 professional achievements, and he will forever be an inspiration to
8 those he leaves behind; now, therefore, be it

9 RESOLVED, That the House of Representatives of the 87th Texas
10 Legislature hereby pay tribute to the memory of Carroll Homer
11 Maxwell Jr. and extend heartfelt sympathy to all who mourn his
12 passing; and, be it further
