in Marshall and Brown McCarroll & Oaks Hartline in Longview during

and immediately after law school, Mr. Khoury began his legal career

14 at the firm of Nichols & Nichols in Longview, where he demonstrated

15 his expertise in state and federal litigation, including personal

16 injury cases as well as complex commercial, insurance, and oil and

17 gas cases; he opened the Khoury Law Firm in 2012, focusing on

18 business litigation, wills, trusts, and probate cases; and

19 WHEREAS, A leader in his profession, Mr. Khoury served the

20 Gregg County Bar Association as president, and he helped organize

21 an effort to bring the Supreme Court of Texas to conduct oral

22 arguments in Longview; he was a member of the State Bar of Texas and

23 served on its Judiciary Relations Committee, and he was also a
