4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle B, Title 4, Health and Safety Code, is
6	amended by adding Chapter 260B to read as follows:
7	CHAPTER 260B. RIGHT TO ESSENTIAL CAREGIVER VISITS FOR CERTAIN
8	FACILITY RESIDENTS
9	Sec. 260B.0001. DEFINITIONS. In this chapter:
10	(1) "Essential caregiver" means a family member,
11	friend, or other individual selected by a facility resident for
12	in-person visits.
13	(2) "Executive commissioner" means the executive
14	commissioner of the Health and Human Services Commission.
15	(3) "Facility" means:
16	(A) a nursing facility licensed under Chapter
17	<u>242; or</u>
18	(B) an assisted living facility licensed under
19	Chapter 247.
20	(4) "Resident" means an individual, including a
21	patient, who resides in a facility.

VISITS. (a) A facility resident has the right to designate at

least one essential caregiver with whom the facility may not

- 1 prohibit in-person visitation. 2 (b) Notwithstanding Subsection (a), the executive 3 commissioner by rule shall develop guidelines to assist facilities in establishing essential caregiver visitation policies and 4 5 procedures. The guidelines must require the facilities to: 6 (1) allow residents to designate for in-person 7 visitation at least one essential caregiver, and more than one if 8 needed; 9 (2) establish a visitation schedule allowing the essential caregiver to visit the resident for the greater of two 10 hours each day or the hours necessary for the caregiver to complete 11 12 all caregiving tasks; (3) establish procedures to enable personal contact 13 14 between the resident and essential caregiver while requiring social 15 distancing between the caregiver and facility staff; 16 (4) obtain a signed acknowledgment from the essential 17 caregiver in which the caregiver agrees to follow the facility's safety protocols, including: 18 19 (A) wearing personal protective equipment while 20 visiting the resident; 21 (B) completing a health screening before entering the facility; 22
 - (5) establish a visitor's log for contact tracing.

(C) submitting to regular viral testing; and

(D) monitoring symptoms, practicing social

distancing, and limiting contact with individuals outside of the

- 3 SECTION 2. Chapter 555, Health and Safety Code, is amended
- 4 by adding Subchapter F to read as follows:
- 5 SUBCHAPTER F. RIGHT TO ESSENTIAL CAREGIVER VISITS
- 6 Sec. 555.201. DEFINITION. In this chapter, "essential
- 7 <u>caregiver" means a family member, friend, or other individual</u>
- 8 selected by a resident for in-person visits.
- 9 Sec. 555.202. RESIDENT'S RIGHT TO ESSENTIAL CAREGIVER
- 10 VISITS. (a) A resident of a state supported living center has the
- 11 right to designate at least one essential caregiver with whom the
- 12 center may not prohibit in-person visitation.
- 13 (b) Notwithstanding Subsection (a), the executive
- 14 commissioner by rule shall develop guidelines to assist state
- 15 <u>supported living centers in establishing essential caregiver</u>
- 16 <u>visitation policies and procedures. The guidelines must require the</u>
- 17 centers to:
- 18 <u>(1) allow residents to designate for</u> in-person
- 19 visitation at least one essential caregiver, and more than one if
- 20 needed;
- 21 (2) establish a visitation schedule allowing the
- 22 <u>essential caregiver to visit the resident for the greater of two</u>
- 23 hours each day or the hours necessary for the caregiver to complete
- 24 all caregiving tasks;
- 25 (3) establish procedures to enable personal contact
- 26 between the resident and essential caregiver while requiring social

- (4) obtain a signed acknowledgement from the essential 1 2 caregiver in which the caregiver agrees to follow the center's safety protocols, including: 3 4 (A) wearing personal protective equipment while 5 visiting the resident; 6 (B) completing a health screening before 7 entering the center; 8 (C) submitting to regular viral testing; and (D) monitoring symptoms, practicing social 9 distancing, and limiting contact with individuals outside of the 10 center; and 11 12 (5) establish a visitor's log for contact tracing. (c) In the event of a conflict between this section and any 13 14 other law, this section prevails. 15 SECTION 3. As soon as practicable after the effective date of this Act, the executive commissioner of the Health and Human 16 Services Commission shall establish the guidelines required by

SECTION 4. This Act takes effect September 1, 2021.
