- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter A, Chapter 191, Health and Safety
- 7 Code, is amended by adding Section 191.00491 to read as follows:
- 8 Sec. 191.00491. BIRTH RECORD ISSUED TO VICTIMS AND CHILDREN
- 9 OF VICTIMS OF DATING OR FAMILY VIOLENCE. On request of an
- 10 individual described by this section, the state registrar, a local
- 11 registrar, or a county clerk shall issue, without payment of a fee,
- 12 a certified copy of the individual's birth record to:
- 13 (1) a victim of dating violence as defined by Section
- 14 <u>71.0021</u>, Family Code;
- 15 (2) a victim of family violence as defined by Section
- 16 51.002, Human Resources Code; or
- 17 (3) a child of a victim described by Subdivision (1) or
- 18 (2).
- 19 SECTION 2. Subchapter E, Chapter 521, Transportation Code,
- 20 is amended by adding Section 521.1016 to read as follows:
- 21 <u>Sec. 521.1016. PERSONAL IDENTIFICATION CERTIFICATE ISSUED</u>
- 22 TO VICTIMS AND CHILDREN OF VICTIMS OF DATING OR FAMILY VIOLENCE.
- 23 (a) In this section:
- 24 (1) "Advocate" has the meaning assigned by Section

- 93.001, Family Code. 1 (2) "Victim of dating violence" means the victim of 2 3 violence described by Section 71.0021, Family Code. (3) "Victim of family violence" has the meaning 4 assigned by Section 51.002, Human Resources Code. 5 6 (b) This section applies to the application for a personal 7 identification certificate only for a victim of dating violence, a victim of family violence, or the child of a victim of dating or 8 9 family violence. 10 (c) Notwithstanding Section 521.101, Section 521.1426, or 11 any other provision of this chapter, an individual described by Subsection (b) may, in applying for a personal identification 12 13 certificate: (1) provide a copy of the individual's birth 14 certificate as proof of the individual's identity and United States 15 citizenship, as applicable; and 16 17 (2) if the individual does not have a residence or domicile, provide a letter certifying the individual is homeless 18 19 issued by: 20 (A) an advocate;

- 4 SECTION 3. Section 521.1811, Transportation Code, is
- 5 amended to read as follows:
- 6 Sec. 521.1811. WAIVER OF FEES FOR FOSTER CHILD OR YOUTH,
- 7 [OR] HOMELESS CHILD OR YOUTH, OR VICTIM OR CHILD OF VICTIM OF DATING
- 8 OR FAMILY VIOLENCE. A person is exempt from the payment of any fee
- 9 for the issuance of a driver's license, as provided under this

- 2 of the Texas mobility fund an amount from the identification fee
- 3 exemption account under Subsection (a) that is equal to the amount
- 4 of the waived fee that would otherwise be deposited to the mobility
- 5 fund.
- 6 (c) The department may not grant an exemption under Section
- 7 521.1015, 521.1016, or 521.1811 if money is not available in the
- 8 identification fee exemption account to meet the requirements of
- 9 Subsection (b).
- 10 SECTION 5. The changes in law made by this Act apply to an
- 11 application for a birth record, driver's license, or personal
- 12 identification certificate submitted on or after the effective date
- 13 of this Act. An application for a birth record, driver's license,
- 14 or personal identification certificate submitted before the
- 15 effective date of this Act is governed by the law in effect on the
- 16 date the application was submitted, and the former law is continued
- 17 in effect for that purpose.
- SECTION 6. This Act takes effect September 1, 2021.
