18	(4) beginning five days before the first day of Diwali
19	and ending at midnight on the last day of Diwali.
20	SECTION 2. Sections 352.051(b) and (d), Local Government
21	Code, are amended to read as follows:
22	(b)(1) The Texas $\underline{A\&M}$ Forest Service in the ordinary course
23	of its activities shall determine whether drought conditions, as
24	defined under Subsection (a)(2), exist on average in any county

The Texas <u>A&M</u> Forest Service shall make available the measurement index guidelines used to 2 3 determine whether drought conditions exist in a particular area. Following any determination that such drought conditions exist, the 4 5 Texas A&M Forest Service shall notify said county or counties when such drought conditions no longer exist. The Texas A&M Forest 6 Service shall make its services available each day during the Texas 7 8 Independence Day, San Jacinto Day, Memorial Day, Fourth of July, Diwali, and December fireworks seasons to respond to the request of 9 10 any county for a determination whether drought conditions exist on average in the county. 11

12 (2) The Texas <u>A&M</u> Forest Service shall be allowed to
13 take such donations of equipment or funds as necessary to aid in the
14 carrying out of this section.

15 (d) To facilitate compliance with an order adopted under16 Subsection (c), the order must be adopted before:

17 (1) February 15 of each year for the Texas18 Independence Day fireworks season;

19 (2) April 1 of each year for the San Jacinto Day20 fireworks season;

21 (3) April 25 of each year for the Cinco de Mayo 22 fireworks season;

23 (4) May 15 of each year for the Memorial Day fireworks24 season;

25 (5) June 15 of each year for the Fourth of July 26 fireworks season; [and]

27 (6) <u>15 days before the beginning of Diwali for the</u>

1 Diwali fireworks season; and

2 <u>(7)</u> December 15 of each year for each December 3 fireworks season.

4 SECTION 3. This Act takes effect September 1, 2021.
