- 2 WHEREAS, The Legislature of the State of Texas honors and
- 3 commemorates the life of Sergio Muñoz Sr., who died July 30, 2020,
- 4 at the age of 68; and
- 5 WHEREAS, Sergio Muñoz was an exemplary citizen, an
- 6 influential political leader, and a dedicated public servant whose
- 7 vision and commitment to serving the less fortunate among us were an
- 8 inspiration to all who knew him; and
- 9 WHEREAS, Born on January 20, 1952, he grew up in Los Ebanos
- 10 and was valedictorian of his graduating class of 1970 at La Joya
- 11 High School; as a young man, he demonstrated exceptional musical
- 12 talent as a trumpet player, vocalist, and songwriter, and he
- 13 performed in numerous local bands, including his own group, Sergio
- 14 Muñoz y Los Incas; he continued his education at Pan American
- 15 University, where he studied social work; and
- 16 WHEREAS, Sergio began his career in public service at the age
- 17 of 18 as a candidate for the La Joya school board; he went on to
- 18 serve two terms in the Texas House of Representatives representing
- 19 District 36, a seat now held by his son, Sergio Muñoz Jr., and he
- 20 remained involved in politics and committed to creating positive
- 21 change throughout his life; he also served as a city manager and
- 22 municipal judge for the City of Palmview and was a successful
- 23 businessman in the insurance industry and in residential and
- 24 commercial land development; and

- 1 WHEREAS, After leaving elected office, he worked as a
  2 lobbyist for various local and municipal interests, and for two
  3 decades, he served as an advocate for the health care industry and
  4 was committed to providing quality care for the elderly; he was a
  5 trusted mentor and advisor to numerous candidates for elected
  6 office, and he held several leadership positions in the Hidalgo
  7 County Democratic Party and was often seen during legislative
  8 sessions supporting and promoting issues of importance to the
- WHEREAS, He was active in a wide range of professional and civic organizations, including the Knights of Columbus, the Private Industry Council, the Lions Club, the La Joya Educational Foundation, and the Touchdown Club in Mission; he took great pleasure in making his morning rounds to visit local restaurants and in spending time surrounded by friends and discussing family, politics, and Texas Longhorn football; and
