A BILL TO BE ENTITLED 1 AN ACT 2 relating to the employment and licensing of border security 3 officers employed by the Department of Public Safety. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Subchapter A, Chapter 411, Government Code, is 5 amended by adding Section 411.02091 to read as follows: 6 Sec. 411.02091. BORDER SECURITY OFFICERS. (a) 7 The department may employ as a border security officer to assist 8 9 department efforts along the Texas-Mexico border an individual who: (1) has served in the United States armed forces and 10 11 received an honorable discharge; and 12 (2) holds a border security officer license issued by 13 the Texas Commission on Law Enforcement. 14 (b) The department shall develop a training program for border security officers that complies with the requirements of 15 16 Subchapter P, Chapter 1701, Occupations Code. (c) The department shall deploy border security officers to 17 serve along the Texas-Mexico border for 60 continuous days out of a 18 90-day period. 19 SECTION 2. Chapter 1701, Occupations Code, is amended by 20 21 adding Subchapter P to read as follows: 22 SUBCHAPTER P. BORDER SECURITY OFFICERS 23 Sec. 1701.751. BORDER SECURITY OFFICER LICENSE. (a) The commission shall adopt rules establishing a border security officer 24

3 (b) The rules adopted under Subsection (a) must provide for 4 an application process for a border security officer license that 5 is similar to the application process for a peace officer license.

6 <u>Sec. 1701.752. ELIGIBILITY. A border security officer</u> 7 <u>license may be issued only to an individual who served in the United</u> 8 <u>States armed forces and received an honorable discharge and</u> 9 <u>satisfies the eligibility requirements established by commission</u> 10 <u>rule.</u>

Sec. 1701.753. REQUIRED TRAINING. The commission, in consultation with the Department of Public Safety, shall establish training requirements for border security officers.

14 <u>Sec. 1701.754. AUTHORITY OF BORDER SECURITY OFFICER. (a)</u> 15 <u>An individual who holds a border security officer license has the</u> 16 <u>same authority as a peace officer except as otherwise provided by</u> 17 <u>commission rule.</u>

(b) The commission, in consultation with the Department of
 Public Safety, shall adopt rules to implement this section.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect on the 91st day after the last day of the legislative session.
