1 WHEREAS, The death of Mario A. Martinez on June 28, 2023, at
2 the age of 69, has profoundly saddened the many people whose lives
3 he touched over the course of a noteworthy career spanning nearly
4 five decades in the legislative community; and

5 WHEREAS, The son of Charlie Martinez Jr. and Mary Louise
6 Martinez, Mario Martinez was born in Bay City on June 2, 1954; he
7 grew up with three siblings, Cecilia, Julia, and Charlie; after
8 graduating from Southwest Texas State University with a bachelor's
9 degree in criminal justice, he began working as a legislative aide
10 to State Representative Tom Uher and rose to become chief of staff;
11 he went on to serve as governmental affairs director for the Texas
12 State Troopers Association for more than a decade; and

13 WHEREAS, Mr. Martinez married the love of his life, Louann,
14 in 1994, and they became the parents of two treasured daughters,
15 Avery and McKenna; the couple founded the consulting firm Martinez
16 & Associates in 1996, and until his passing, Mr. Martinez
17 represented major industries and law enforcement entities,
18 providing expertise regarding a number of challenging issues; a
19 loyal and diligent advocate for his clients, he distinguished
20 himself through his integrity, professionalism, and deep expertise
21 in the inner workings of government; his big heart, engaging
22 personality, and wonderful sense of humor brought him numerous
23 close friendships, and he was a kind mentor to many; and

24 WHEREAS, Above all, Mr. Martinez was dedicated to his family;

1 he encouraged his daughters to follow their dreams while instilling
2 the importance of education, a strong work ethic, and good
3 character; in addition, he shared with them his love of hunting,
4 fishing, and adopting stray animals; he also enjoyed spending time
5 in Rockport on his boat; and

6 WHEREAS, Deeply caring, Mario Martinez sought to use his
7 skill and influence not only for the benefit of his clients, but
8 also for the betterment of Texas, and he will be greatly missed by
9 all who were privileged to share in the richness of his life; now,
10 therefore, be it

12 Legislature, 2nd Called Session, hereby pay tribute to the memory
13 of Mario A. Martinez and extend sincere condolences to the members
