1           WHEREAS, Flower Mound lost an engaged citizen, an admired  
2 veteran, and a friend to many with the passing of Donald Joseph  
3 Shields on July 3, 2023, at the age of 84; and

4           WHEREAS, The son of George Shields and Mary Rita Healy  
5 Shields, Don Shields was born in Buffalo, New York, on November 5,  
6 1938; he proudly served his country in the United States Navy for 22  
7 years, attaining the rank of master chief petty officer; through  
8 the years, he continued to be known as "Master Chief" to those who  
9 knew him well; and

10           WHEREAS, Mr. Shields was deeply patriotic and very dedicated  
11 to his community; a staunch Republican, he gave generously of his  
12 time and talents in behalf of campaigns for conservative candidates  
13 and causes; he attended all events and meetings of the Flower Mound  
14 Area Republican Club and often represented the group outside  
15 polling places; he was also a longtime member of the NRA; and

16           WHEREAS, Devoted to his family, Mr. Shields shared a  
17 fulfilling 50-year marriage with his wife, June Ann Shields; he was  
18 blessed with four children, Kirk, Kara, Karl, and Keath, as well as  
19 four grandchildren, Craig, Kaitlin, Cole, and Cameron, and he  
20 delighted in supporting them at their activities; sustained by a  
21 strong faith, Mr. Shields was a valued member of his church, where  
22 he served on the security team; he loved music, especially  
23 traditional barbershop singing, and his family enjoyed hearing him  
24 play the harmonica and tap out melodies on the piano; and

1           WHEREAS, Although Don Shields will be sadly missed, his  
2 faith, patriotism, and civic involvement will remain a lasting  
3 source of inspiration to those he leaves behind; now, therefore, be

7 Donald Joseph Shields and extend sincere sympathy to the members of
