- 9 not considered to owe any tax for a period if:
- 10 (1) the amount of tax computed for the taxable entity
- 11 is less than \$1,000; or
- 12 (2) the amount of the taxable entity's total revenue
- 13 from its entire business is less than or equal to $\frac{$2.47}{}$ [\$\frac{\$1}{}] million
- 14 or the amount determined under Section 171.006 per 12-month period
- 15 on which margin is based.
- SECTION 2. Section 171.204(b), Tax Code, is amended to read
- 17 as follows:
- 18 (b) The comptroller may <u>not</u> require a taxable entity that
- 19 does not owe any tax because of the application of Section
- 20 171.002(d)(2) to file an [abbreviated] information report with the
- 21 comptroller [stating the amount of the taxable entity's total
- 22 revenue from its entire business. The comptroller may not require
- 23 a taxable entity described by this subsection to file an
- 24 information report that requires the taxable entity to report or

- 1 compute its margin].
- 2 SECTION 3. Section 171.204(d), Tax Code, is repealed.
- 3 SECTION 4. The changes in law made by this Act apply only to
- 4 a report originally due on or after January 1, 2024.
- 5 SECTION 5. This Act takes effect only if S.B. 2 or similar
- 6 legislation of the 88th Legislature, 2nd Called Session, 2023,
- 7 relating to providing property tax relief through the public school
- 8 finance system, exemptions, limitations on appraisals and taxes,
- 9 and property tax administration becomes law in a manner described
- 10 by Section 2001.006(a)(2), Government Code. If legislation
- 11 described by this section does not become law in a manner described
- 12 by Section 2001.006(a)(2), Government Code, this Act has no effect.
- 13 SECTION 6. Except as otherwise provided by this Act, this
- 14 Act takes effect January 1, 2024.
