- 13 preceded her father in death, and their family eventually grew to
- 14 include five grandchildren, Murphey, Allie, Weslee, Wendy, and

- WHEREAS, A lifelong rancher, Mr. Black worked livestock in
- 18 Crockett, Pecos, Terrell, and Val Verde Counties, and for several
