- 1 WHEREAS, Residents of The Colony are mourning the loss of 2 former mayor John Curtis Dillard II, who passed away on 3 September 20, 2023, at the age of 75; and
- WHEREAS, The son of John and Alice Dillard, John Dillard was born on August 30, 1948, and grew up in Bessemer, Alabama; while completing his bachelor's degree in business at Amberton University, he enlisted in the National Guard; he served
- 8 principally in the 49th Armored Division of the Texas Army National
- 9 Guard; over the course of 25 years in the military, he graduated
- 10 from the U.S. Army Command and General Staff College and U.S. Army
- 11 Armor School, and he retired as a lieutenant colonel in the Army
- 12 Reserve; his civilian career spanned more than 40 years in the
- 13 commercial building products field, and he won many professional
- 14 awards before his retirement as a district manager with Siplast in
- 15 2016; and
- 16 WHEREAS, Mr. Dillard was highly engaged in civic life for
- 17 nearly four decades; after serving on The Colony City Council from
- 18 1992 to 2002, he went on to serve two terms as mayor; he shared his
- 19 expertise with the board of the Denton County Transportation
- 20 Authority and Denton County Building and Maintenance Committee,
- 21 among other such organizations, and he was a founding member of The
- 22 Colony Economic Development Corporation, the Windhaven Peninsula
- 23 Development Committee, and the HWY 121 Task Force; and
- 24 WHEREAS, Active in the Denton County Republican Party since

- 1 1986, Mr. Dillard served in numerous capacities, including senate
- 2 district committee member, state delegate, and county chair; he
- 3 regularly served as an election judge or clerk, and he was a
- 4 founding member of the Denton County Conservative Coalition; he was
- 5 also a longtime member of the Legacy Republican Club; in 2016, he
- 6 was elected as the presidential elector for Congressional District
- 7 26; moreover, he was an Eagle Scout and a lifetime member of the
- 8 National Rifle Association and Texas State Rifle Association;
- 9 sharing his skill, he served as a 4-H shooting sports instructor;

- 11 WHEREAS, Mr. Dillard was a man of strong faith and served in
- 12 leadership roles at several churches; the devoted husband of Nancy
- 13 Dillard, he took great pride in their children, Ashley, Elizabeth,
- 14 and Steven, and three treasured granddaughters, Caroline,
- 15 Penelope, and Eva; and
- 16 WHEREAS, Through his service to his community and his
- 17 country, John Dillard set an inspiring example for all, and he will
- 18 be remembered with great admiration by all who were privileged to
- 19 know him; now, therefore, be it
