

R E S O L U T I O N

1           WHEREAS, The citizens of San Angelo lost an admired community  
2 leader with the passing of Wylie O. Webb on June 24, 2023, at the age  
3 of 90; and

4           WHEREAS, Wylie Webb was born to Clyde and Oval Webb in San  
5 Angelo on March 17, 1933; after graduating from San Angelo High  
6 School, he joined the U.S. Air Force, training as an aircraft and  
7 engine mechanic and as a B-29 flight engineer and subsequently  
8 serving at an air base in South Korea and at Tinker Air Force Base in  
9 Oklahoma; following his military service, he attended San Angelo  
10 College and went on to earn a business administration degree from  
11 The University of Texas at Austin; and

12           WHEREAS, Over the course of his career as a certified public  
13 accountant, Mr. Webb worked for the Jones, Freeze, Hay & Company  
14 accounting firm and then for Hall, McCoulsky, and Bachman, where he  
15 became a partner; in 1977, he cofounded the Webb & Webb accounting  
16 firm, and he retired from his practice in 2017, concluding an  
17 exemplary tenure that spanned four decades; and

18           WHEREAS, Mr. Webb was elected to the San Angelo City  
19 Commission in 1968 and as mayor of the city two years later; he  
20 demonstrated tremendous leadership in that office, helping to  
21 establish permanent underground water supplies for the city's three  
22 reservoirs; he also served as president of the San Angelo  
23 Independent School District board and the San Angelo Chamber of  
24 Commerce and as a member of the Board of City Development and the

1 River Corridor Commission; moreover, he was a San Angelo Chamber of  
2 Commerce Citizen of the Year, a lifetime board member of the Mary  
3 Ellen Kent Bunyard Family Foundation, and a recipient of the  
4 Distinguished Public Service Award from the Texas Society of  
5 Certified Public Accountants; and

6 WHEREAS, In all his endeavors, Mr. Webb enjoyed the love and  
7 support of his wife of 54 years, Anita Glyn Russell Webb; he took  
8 great pride in his daughter, Aleesa Shawn Webb, and his grandson,  
9 Wylie "Gage" Hahn; and

10 WHEREAS, Although Wylie Webb is deeply missed, memories of  
11 his integrity, his kindness, and his devotion to his family remain  
12 to comfort and inspire those he leaves behind; now, therefore, be it

13 RESOLVED, That the House of Representatives of the 88th Texas  
14 Legislature, 4th Called Session, hereby pay tribute to the life of  
15 Wylie O. Webb and extend heartfelt condolences to all who mourn his  
16 passing; and, be it further

17 RESOLVED, That an official copy of this resolution be  
18 prepared for his family and that when the Texas House of  
19 Representatives adjourns this day, it do so in memory of Wylie Webb.
