

R E S O L U T I O N

1 WHEREAS, The family and friends of U.S. Army Command Sergeant
2 Major Charles Russell Turbeville of Copperas Cove suffered an
3 immeasurable loss with his passing on November 30, 2023, at the age
4 of 66; and

5 WHEREAS, Charles Turbeville was born on June 7, 1957, in
6 Charleston, South Carolina; he earned a bachelor of science degree
7 from Embry-Riddle Aeronautical University and a master of arts
8 degree in education from the University of Phoenix; and

9 WHEREAS, Answering his nation's call to duty, Mr. Turbeville
10 enlisted in the U.S. Army in 1975, first serving with the 4th
11 Battalion, 68th Armor Regiment, 82nd Airborne Division at Fort
12 Bragg, North Carolina, as a cavalry scout; he was later stationed at
13 Fort Rucker, Alabama, Fort Campbell, Kentucky, U.S. Army Garrison
14 Humphreys, South Korea, Fort Hood, Texas, and Dolan Barracks,
15 Germany, and he deployed with Operation Desert Shield/Desert Storm
16 to provide air traffic control support; at the time of his
17 retirement from federal service in 1995, he was first sergeant of
18 the Headquarters Troop, 3rd Squadron, 6th Cavalry, 6th Cavalry
19 Brigade at Fort Hood; and

20 WHEREAS, Command Sergeant Major Turbeville went on to join
21 the Texas State Guard in 2013, and in the course of his exemplary
22 eight-year tenure, he served as the senior enlisted advisor for the
23 Texas Medical Brigade and as the SEA for the 1st Battalion, 2nd
24 Regiment, Army Component; his military awards and decorations

1 included three Meritorious Service Medals, two Army Commendation
2 Medals, the Korean Defense Service Medal, three Texas Outstanding
3 Service Medals, five Texas Medals of Merit, the Texas Faithful
4 Service Medal, and the Texas State Guard Service Medal; and

5 WHEREAS, In all his endeavors, Command Sergeant Major
6 Turbeville enjoyed the love and support of his wife, Brenda, and
7 their two children, Megan and Adam; and

8 WHEREAS, Charles Turbeville lived a rich and purposeful life
9 dedicated to his family, his state, and his nation, and he leaves
10 behind a legacy of public service that his loved ones can remember
11 with pride; now, therefore, be it

12 RESOLVED, That the House of Representatives of the 88th Texas
13 Legislature, 4th Called Session, hereby pay tribute to the memory
14 of U.S. Army Command Sergeant Major Charles Russell Turbeville and
15 extend deepest condolences to his relatives and friends; and, be it
