A BILL TO BE ENTITLED

1	AN ACT
2	relating to authorizing the use of a writing portfolio assessment
3	to assess writing performance for public school students.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 39, Education Code, is
6	amended by adding Section 39.02301 to read as follows:
7	Sec. 39.02301. OPTIONAL USE OF WRITING PORTFOLIO
8	ASSESSMENT. (a) A school district may elect to use a writing
9	portfolio assessment to assess writing performance for students
10	enrolled in the district as an alternative to administering the
11	portion of a reading assessment instrument under Section 39.023(a)
12	or English I or English II end-of-course assessment instrument
13	under Section 39.023(c) that is not presented in a multiple choice
14	format.
15	(b) A school district that elects to use a writing portfolio
16	assessment under this section shall design the assessment in
17	consultation with a public or private institution of higher
18	education and submit the assessment to the agency for approval. The
19	agency shall approve the assessment if the assessment is:
20	(1) determined by the public or private institution of
21	higher education that consulted on the design of the assessment to
22	be valid and reliable; and
23	(2) designed to assess:
24	(A) a student's mastery of the essential

- 1 knowledge and skills in writing through timed writing samples;
- 2 (B) improvement of a student's writing skills
- 3 from the beginning of the school year to the end of the school year;
- 4 (C) a student's ability to follow the writing
- 5 process from rough draft to final product; and
- 6 (D) a student's ability to produce more than one
- 7 type of writing style.
- 8 (c) A school district that elects to use a writing portfolio
- 9 assessment under this section may adopt a policy allowing the
- 10 assessment to be scored by a classroom teacher assigned to the same
- 11 campus as the student to whom the assessment is administered. The
- 12 district may coordinate with the regional education service center
- 13 for the district's region in grading the assessments.
- 14 (d) A school district that elects to use a writing portfolio
- 15 assessment under this section is not required to administer the
- 16 portion of a reading assessment instrument under Section 39.023(a)
- 17 or English I or English II end-of-course assessment instrument
- 18 under Section 39.023(c) that is not presented in a multiple choice
- 19 format during the period the district is administering the writing
- 20 portfolio assessment. The agency shall, to the greatest extent
- 21 practicable, apply cost savings that result from the exemption
- 22 under this subsection to offset the costs accrued under this
- 23 <u>section.</u>
- (e) The commissioner shall adopt rules as necessary to
- 25 implement this section.
- 26 SECTION 2. This Act applies beginning with the 2023-2024
- 27 school year.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this

5 Act takes effect September 1, 2023.
