- 24 SECTION 2. Article 12.02, Code of Criminal Procedure, is
- 25 amended to read as follows:
- 26 Art. 12.02. MISDEMEANORS. (a) Except as provided by
- 27 Subsection (b), the following charging instruments may be presented

- 1 within two years from the date of the commission of the offense, and
- 2 not afterward:
- 3 (1) an [An] indictment or information for any Class A
- 4 or Class B misdemeanor; and
- 5 (2) a [may be presented within two years from the date
- 6 of the commission of the offense, and not afterward.
- 7 $\left[\frac{b}{A}\right]$ complaint or information for any Class C
- 8 misdemeanor.
- 9 (b) An indictment, information, or complaint, as
- 10 applicable, for assault under Section 22.01, Penal Code, may be
- 11 presented within $\underline{\text{three}}$ [$\underline{\text{two}}$] years from the date of the commission
- 12 of the offense, and not afterward, if the offense:
- 13 (1) is punishable as a misdemeanor; and
- 14 (2) was committed against a person whose relationship
- 15 to or association with the defendant is described by Section
- 16 <u>71.0021(b)</u>, 71.003, or 71.005, Family Code.
- 17 SECTION 3. The change in law made by this Act does not apply
- 18 to an offense if the prosecution of that offense becomes barred by
- 19 limitation before the effective date of this Act. The prosecution
- 20 of that offense remains barred as if this Act had not taken effect.
- 21 SECTION 4. This Act takes effect September 1, 2023.
