H.B. No. 446

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the terminology used in statute to refer to
3 intellectual disability and certain references to abolished health
4 and human services agencies.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 ARTICLE 1. CIVIL PRACTICE AND REMEDIES CODE PROVISIONS

7 SECTION 1.01. Sections 74.001(a)(11) and (18), Civil
8 Practice and Remedies Code, are amended to read as follows:

9 (11) "Health care institution" includes:

- 10 (A) an ambulatory surgical center;
- 11 (B) an assisted living facility licensed under
12 Chapter 247, Health and Safety Code;
- 13 (C) an emergency medical services provider;
- 14 (D) a health services district created under
15 Chapter 287, Health and Safety Code;
- 16 (E) a home and community support services agency;
- 17 (F) a hospice;
- 18 (G) a hospital;
- 19 (H) a hospital system;
- 20 (I) an intermediate care facility for
21 individuals with an intellectual disability [~~the mentally~~
22 ~~retarded~~] or a home and community-based services waiver program for
23 individuals [~~persons~~] with an intellectual disability [~~mental~~
24 ~~retardation~~] adopted in accordance with Section 1915(c) of the

1 federal Social Security Act (42 U.S.C. Section 1396n), as amended;

2 (J) a nursing home; or

3 (K) an end stage renal disease facility licensed
4 under Section 251.011, Health and Safety Code.

5 (18) "Intermediate care facility for individuals with
6 an intellectual disability [~~the mentally retarded~~]" means a
7 licensed public or private institution to which Chapter 252, Health
8 and Safety Code, applies.

9 ARTICLE 2. CODE OF CRIMINAL PROCEDURE PROVISIONS

10 SECTION 2.01. Article 46C.001(4), Code of Criminal
11 Procedure, is amended to read as follows:

12 (4) "Intellectual disability [~~Mental retardation~~]"
13 has the meaning assigned by Section 591.003, Health and Safety
14 Code.

15 SECTION 2.02. Article 46C.105(c), Code of Criminal
16 Procedure, is amended to read as follows:

17 (c) The examiner shall submit a separate report stating the
18 examiner's observations and findings concerning:

19 (1) whether the defendant is presently a person with a
20 mental illness and requires court-ordered mental health services
21 under Subtitle C, Title 7, Health and Safety Code; or

22 (2) whether the defendant is presently a person with
23 an intellectual disability [~~mental retardation~~].

24 SECTION 2.03. Article 46C.201, Code of Criminal Procedure,
25 is amended to read as follows:

26 Art. 46C.201. DISPOSITION: NONDANGEROUS CONDUCT. (a) If
27 the court determines that the offense of which the person was

1 acquitted did not involve conduct that caused serious bodily injury
2 to another person, placed another person in imminent danger of
3 serious bodily injury, or consisted of a threat of serious bodily
4 injury to another person through the use of a deadly weapon, the
5 court shall determine whether there is evidence to support a
6 finding that the person is a person with a mental illness or an
7 intellectual disability [~~with mental retardation~~].

8 (b) If the court determines that there is evidence to
9 support a finding of mental illness or intellectual disability
10 [~~mental retardation~~], the court shall enter an order transferring
11 the person to the appropriate court for civil commitment
12 proceedings to determine whether the person should receive
13 court-ordered mental health services under Subtitle C, Title 7,
14 Health and Safety Code, or be committed to a residential care
15 facility to receive intellectual disability [~~mental retardation~~]
16 services under Subtitle D, Title 7, Health and Safety Code. The
17 court may also order the person:

18 (1) detained in jail or any other suitable place
19 pending the prompt initiation and prosecution of appropriate civil
20 proceedings by the attorney representing the state or other person
21 designated by the court; or

22 (2) placed in the care of a responsible person on
23 satisfactory security being given for the acquitted person's proper
24 care and protection.

25 SECTION 2.04. Article [46C.252\(c\)](#), Code of Criminal
26 Procedure, is amended to read as follows:

27 (c) The report must address:

1 (1) whether the acquitted person has a mental illness
2 or an intellectual disability [~~mental retardation~~] and, if so,
3 whether the mental illness or intellectual disability [~~mental~~
4 ~~retardation~~] is severe;

5 (2) whether as a result of any severe mental illness or
6 intellectual disability [~~mental retardation~~] the acquitted person
7 is likely to cause serious harm to another;

8 (3) whether as a result of any impairment the
9 acquitted person is subject to commitment under Subtitle C or D,
10 Title 7, Health and Safety Code;

11 (4) prospective treatment and supervision options, if
12 any, appropriate for the acquitted person; and

13 (5) whether any required treatment and supervision can
14 be safely and effectively provided as outpatient or community-based
15 treatment and supervision.

16 SECTION 2.05. Article [46C.253\(b\)](#), Code of Criminal
17 Procedure, is amended to read as follows:

18 (b) At the hearing, the court shall address:

19 (1) whether the person acquitted by reason of insanity
20 has a severe mental illness or a severe intellectual disability
21 [~~mental retardation~~];

22 (2) whether as a result of any mental illness or
23 intellectual disability [~~mental retardation~~] the person is likely
24 to cause serious harm to another; and

25 (3) whether appropriate treatment and supervision for
26 any mental illness or intellectual disability [~~mental retardation~~]
27 rendering the person dangerous to another can be safely and

1 effectively provided as outpatient or community-based treatment
2 and supervision.

3 SECTION 2.06. Article 46C.255(c), Code of Criminal
4 Procedure, is amended to read as follows:

5 (c) If a hearing is held before a jury and the jury
6 determines that the person has a mental illness or an intellectual
7 disability [~~mental retardation~~] and is likely to cause serious harm
8 to another, the court shall determine whether inpatient treatment
9 or residential care is necessary to protect the safety of others.

10 SECTION 2.07. Article 46C.256(a), Code of Criminal
11 Procedure, is amended to read as follows:

12 (a) The court shall order the acquitted person committed to
13 a mental hospital or other appropriate facility for inpatient
14 treatment or residential care if the state establishes by clear and
15 convincing evidence that:

16 (1) the person has a severe mental illness or a severe
17 intellectual disability [~~mental retardation~~];

18 (2) the person, as a result of that mental illness or
19 intellectual disability [~~mental retardation~~], is likely to cause
20 serious bodily injury to another if the person is not provided with
21 treatment and supervision; and

22 (3) inpatient treatment or residential care is
23 necessary to protect the safety of others.

24 SECTION 2.08. Article 46C.257(a), Code of Criminal
25 Procedure, is amended to read as follows:

26 (a) The court shall order the acquitted person to receive
27 outpatient or community-based treatment and supervision if:

1 (1) the state establishes by clear and convincing
2 evidence that the person:

3 (A) has a severe mental illness or a severe
4 intellectual disability [~~mental retardation~~]; and

5 (B) as a result of that mental illness or
6 intellectual disability [~~mental retardation~~] is likely to cause
7 serious bodily injury to another if the person is not provided with
8 treatment and supervision; and

9 (2) the state fails to establish by clear and
10 convincing evidence that inpatient treatment or residential care is
11 necessary to protect the safety of others.

12 SECTION 2.09. Articles 46C.258(a) and (b), Code of Criminal
13 Procedure, are amended to read as follows:

14 (a) The head of the facility to which an acquitted person is
15 committed has, during the commitment period, a continuing
16 responsibility to determine:

17 (1) whether the acquitted person continues to have a
18 severe mental illness or a severe intellectual disability [~~mental~~
19 ~~retardation~~] and is likely to cause serious harm to another because
20 of any severe mental illness or severe intellectual disability
21 [~~mental retardation~~]; and

22 (2) if so, whether treatment and supervision cannot be
23 safely and effectively provided as outpatient or community-based
24 treatment and supervision.

25 (b) The head of the facility must notify the committing
26 court and seek modification of the order of commitment if the head
27 of the facility determines that an acquitted person no longer has a

1 severe mental illness or a severe intellectual disability [~~mental~~
2 ~~retardation~~], is no longer likely to cause serious harm to another,
3 or that treatment and supervision can be safely and effectively
4 provided as outpatient or community-based treatment and
5 supervision.

6 SECTION 2.10. Article 46C.260(d), Code of Criminal
7 Procedure, is amended to read as follows:

8 (d) The executive commissioner shall appoint a review board
9 of five members, including one psychiatrist licensed to practice
10 medicine in this state and two persons who work directly with
11 persons with mental illnesses or persons with intellectual
12 disabilities [~~mental retardation~~], to determine whether the person
13 is manifestly dangerous and, as a result of the danger the person
14 presents, requires continued placement in a maximum security unit.

15 SECTION 2.11. Article 46C.263(d), Code of Criminal
16 Procedure, is amended to read as follows:

17 (d) The court may order that supervision of the acquitted
18 person be provided by the appropriate community supervision and
19 corrections department or the facility administrator of a community
20 center that provides mental health or intellectual disability
21 [~~mental retardation~~] services.

22 SECTION 2.12. Article 46C.268(f), Code of Criminal
23 Procedure, is amended to read as follows:

24 (f) The court shall discharge the acquitted person from all
25 court-ordered commitment and treatment and supervision and
26 terminate the court's jurisdiction over the person if the court
27 finds that the acquitted person has established by a preponderance

1 of the evidence that:

2 (1) the acquitted person does not have a severe mental
3 illness or a severe intellectual disability [~~mental retardation~~];
4 or

5 (2) the acquitted person is not likely to cause
6 serious harm to another because of any severe mental illness or
7 intellectual disability [~~mental retardation~~].

8 ARTICLE 3. FAMILY CODE PROVISIONS

9 SECTION 3.01. Sections 51.20(a), (b), (c), and (d), Family
10 Code, are amended to read as follows:

11 (a) At any stage of the proceedings under this title,
12 including when a child is initially detained in a pre-adjudication
13 secure detention facility or a post-adjudication secure
14 correctional facility, the juvenile court may, at its discretion or
15 at the request of the child's parent or guardian, order a child who
16 is referred to the juvenile court or who is alleged by a petition or
17 found to have engaged in delinquent conduct or conduct indicating a
18 need for supervision to be examined by a disinterested expert,
19 including a physician, psychiatrist, or psychologist, qualified by
20 education and clinical training in mental health or intellectual
21 and developmental disabilities [~~mental retardation~~] and
22 experienced in forensic evaluation, to determine whether the child
23 has a mental illness as defined by Section 571.003, Health and
24 Safety Code, is a person with an intellectual disability [~~mental~~
25 ~~retardation~~] as defined by Section 591.003, Health and Safety Code,
26 or suffers from chemical dependency as defined by Section 464.001,
27 Health and Safety Code. If the examination is to include a

1 determination of the child's fitness to proceed, an expert may be
2 appointed to conduct the examination only if the expert is
3 qualified under Subchapter B, Chapter 46B, Code of Criminal
4 Procedure, to examine a defendant in a criminal case, and the
5 examination and the report resulting from an examination under this
6 subsection must comply with the requirements under Subchapter B,
7 Chapter 46B, Code of Criminal Procedure, for the examination and
8 resulting report of a defendant in a criminal case.

9 (b) If, after conducting an examination of a child ordered
10 under Subsection (a) and reviewing any other relevant information,
11 there is reason to believe that the child has a mental illness or an
12 intellectual disability [~~mental retardation~~] or suffers from
13 chemical dependency, the probation department shall refer the child
14 to the local mental health authority or local intellectual and
15 developmental disability [~~mental retardation~~] authority or to
16 another appropriate and legally authorized agency or provider for
17 evaluation and services, unless the prosecuting attorney has filed
18 a petition under Section 53.04.

19 (c) If, while a child is under deferred prosecution
20 supervision or court-ordered probation, a qualified professional
21 determines that the child has a mental illness or an intellectual
22 disability [~~mental retardation~~] or suffers from chemical
23 dependency and the child is not currently receiving treatment
24 services for the mental illness, intellectual disability [~~mental~~
25 ~~retardation~~], or chemical dependency, the probation department
26 shall refer the child to the local mental health authority or local
27 intellectual and developmental disability [~~mental retardation~~]

1 authority or to another appropriate and legally authorized agency
2 or provider for evaluation and services.

3 (d) A probation department shall report each referral of a
4 child to a local mental health authority or local intellectual and
5 developmental disability [~~mental retardation~~] authority or another
6 agency or provider made under Subsection (b) or (c) to the Texas
7 Juvenile Justice Department in a format specified by the
8 department.

9 SECTION 3.02. Section 54.0408, Family Code, is amended to
10 read as follows:

11 Sec. 54.0408. REFERRAL OF CHILD EXITING PROBATION TO MENTAL
12 HEALTH AUTHORITY OR INTELLECTUAL AND DEVELOPMENTAL DISABILITY
13 [~~MENTAL RETARDATION~~] AUTHORITY. A juvenile probation officer shall
14 refer a child who has been determined to have a mental illness or an
15 intellectual disability [~~mental retardation~~] to an appropriate
16 local mental health authority or local intellectual and
17 developmental disability [~~mental retardation~~] authority at least
18 three months before the child is to complete the child's juvenile
19 probation term unless the child is currently receiving treatment
20 from the local mental health authority or local intellectual and
21 developmental disability [~~mental retardation~~] authority of the
22 county in which the child resides.

23 SECTION 3.03. Section 58.0051(a)(2), Family Code, is
24 amended to read as follows:

25 (2) "Juvenile service provider" means a governmental
26 entity that provides juvenile justice or prevention, medical,
27 educational, or other support services to a juvenile. The term

1 includes:

2 (A) a state or local juvenile justice agency as
3 defined by Section 58.101;

4 (B) health and human services agencies, as
5 defined by Section 531.001, Government Code, and the Health and
6 Human Services Commission;

7 (C) the Department of Family and Protective
8 Services;

9 (D) the Department of Public Safety;

10 (E) the Texas Education Agency;

11 (F) an independent school district;

12 (G) a juvenile justice alternative education
13 program;

14 (H) a charter school;

15 (I) a local mental health authority or local
16 intellectual and developmental disability [~~mental retardation~~]
17 authority;

18 (J) a court with jurisdiction over juveniles;

19 (K) a district attorney's office;

20 (L) a county attorney's office; and

21 (M) a children's advocacy center established
22 under Section 264.402.

23 ARTICLE 4. FINANCE CODE PROVISIONS

24 SECTION 4.01. Section 393.624(a), Finance Code, is amended
25 to read as follows:

26 (a) A credit access business may not advertise on the
27 premises of a nursing facility, assisted living facility, group

1 home, intermediate care facility for persons with an intellectual
2 disability [~~mental retardation~~], or other similar facility subject
3 to regulation by the Health and Human Services Commission
4 [~~Department of Aging and Disability Services~~].

5 ARTICLE 5. GOVERNMENT CODE PROVISIONS

6 SECTION 5.01. Section 54A.209(a), Government Code, is
7 amended to read as follows:

8 (a) Except as limited by an order of referral, an associate
9 judge may:

- 10 (1) conduct a hearing;
- 11 (2) hear evidence;
- 12 (3) compel production of relevant evidence;
- 13 (4) rule on the admissibility of evidence;
- 14 (5) issue a summons for the appearance of witnesses;
- 15 (6) examine a witness;
- 16 (7) swear a witness for a hearing;
- 17 (8) make findings of fact on evidence;
- 18 (9) formulate conclusions of law;
- 19 (10) rule on pretrial motions;
- 20 (11) recommend the rulings, orders, or judgment to be
21 made in a case;
- 22 (12) regulate all proceedings in a hearing before the
23 associate judge;
- 24 (13) take action as necessary and proper for the
25 efficient performance of the duties required by the order of
26 referral;
- 27 (14) order the attachment of a witness or party who

1 fails to obey a subpoena;

2 (15) order the detention of a witness or party found
3 guilty of contempt, pending approval by the referring court as
4 provided by Section 54A.214;

5 (16) without prejudice to the right to a de novo
6 hearing under Section 54A.216, render and sign:

7 (A) a final order agreed to in writing as to both
8 form and substance by all parties;

9 (B) a final default order;

10 (C) a temporary order;

11 (D) a final order in a case in which a party files
12 an unrevoked waiver made in accordance with Rule 119, Texas Rules of
13 Civil Procedure, that waives notice to the party of the final
14 hearing or waives the party's appearance at the final hearing;

15 (E) an order specifying that the court clerk
16 shall issue:

17 (i) letters testamentary or of
18 administration; or

19 (ii) letters of guardianship; or

20 (F) an order for inpatient or outpatient mental
21 health, intellectual disability [~~mental retardation~~], or chemical
22 dependency services or an order authorizing psychoactive
23 medications; and

24 (17) sign a final order that includes a waiver of the
25 right to a de novo hearing in accordance with Section 54A.216.

26 SECTION 5.02. Section 76.003(c), Government Code, is
27 amended to read as follows:

1 (c) The community justice council shall appoint a community
2 justice task force to provide support staff for the development of a
3 community justice plan. The task force may consist of any number of
4 members, but must [~~should~~] include:

5 (1) the county or regional director of the Health and
6 Human Services Commission, or the division of the commission
7 performing the functions previously performed by the Texas
8 Department of Human Services, with responsibility for the area
9 served by the department;

10 (2) the chief of police of the most populous
11 municipality served by the department;

12 (3) the chief juvenile probation officer of the
13 juvenile probation office serving the most populous area served by
14 the department;

15 (4) the superintendent of the most populous school
16 district served by the department;

17 (5) the supervisor of the Department of Public Safety
18 region closest to the department, or the supervisor's designee;

19 (6) the county or regional director of the Health and
20 Human Services Commission, or the division of the commission
21 performing the functions previously performed by the Texas
22 Department of Mental Health and Mental Retardation, with
23 responsibility for the area served by the department;

24 (7) a substance abuse treatment professional
25 appointed by the Council of Governments serving the area served by
26 the department;

27 (8) the department director;

1 (9) the local or regional representative of the parole
2 division of the Texas Department of Criminal Justice with
3 responsibility for the area served by the department;

4 (10) the representative of the Texas Workforce
5 Commission with responsibility for the area served by the
6 department;

7 (11) the representative of the Health and Human
8 Services Commission, or the division of the commission performing
9 the functions previously performed by the Department of Assistive
10 and Rehabilitative Services, with responsibility for the area
11 served by the department;

12 (12) a licensed attorney who practices in the area
13 served by the department and whose practice consists primarily of
14 criminal law;

15 (13) a court administrator, if one serves the area
16 served by the department;

17 (14) a representative of a community service
18 organization that provides adult treatment, educational, or
19 vocational services to the area served by the department;

20 (15) a representative of an organization in the area
21 served by the department that is actively involved in issues
22 relating to defendants' rights, chosen by the county commissioners
23 and county judges of the counties served by the department; and

24 (16) an advocate for rights of victims of crime and
25 awareness of issues affecting victims.

26 SECTION 5.03. Section [125.001](#)(a), Government Code, is
27 amended to read as follows:

1 (a) In this chapter, "mental health court program" means a
2 program that has the following essential characteristics:

3 (1) the integration of mental illness treatment
4 services and intellectual disability [~~mental retardation~~] services
5 in the processing of cases in the judicial system;

6 (2) the use of a nonadversarial approach involving
7 prosecutors and defense attorneys to promote public safety and to
8 protect the due process rights of program participants;

9 (3) early identification and prompt placement of
10 eligible participants in the program;

11 (4) access to mental illness treatment services and
12 intellectual disability [~~mental retardation~~] services;

13 (5) ongoing judicial interaction with program
14 participants;

15 (6) diversion of defendants who potentially have a
16 mental illness [~~mentally ill~~] or an intellectual disability
17 [~~mentally retarded defendants~~] to needed services as an alternative
18 to subjecting those defendants to the criminal justice system;

19 (7) monitoring and evaluation of program goals and
20 effectiveness;

21 (8) continuing interdisciplinary education to promote
22 effective program planning, implementation, and operations; and

23 (9) development of partnerships with public agencies
24 and community organizations, including local intellectual and
25 developmental disability [~~mental retardation~~] authorities.

26 SECTION 5.04. Section [125.002](#), Government Code, is amended
27 to read as follows:

1 Sec. 125.002. AUTHORITY TO ESTABLISH PROGRAM. The
2 commissioners court of a county may establish a mental health court
3 program for persons who:

4 (1) have been arrested for or charged with a
5 misdemeanor or felony; and

6 (2) are suspected by a law enforcement agency or a
7 court of having a mental illness or an intellectual disability
8 [~~mental retardation~~].

9 SECTION 5.05. Section 403.252, Government Code, is amended
10 to read as follows:

11 Sec. 403.252. EXCEPTIONS. This subchapter does not apply
12 to:

13 (1) state agency funds located completely outside the
14 state treasury;

15 (2) the petty cash accounts maintained by the [~~Texas~~
16 Department of State Health Services [~~Mental Health and Mental~~
17 ~~Retardation~~] under Section 533.037(d), Health and Safety Code
18 [~~2.17(b)(3), Texas Mental Health and Mental Retardation Act~~
19 [~~Article 5547-202, Vernon's Texas Civil Statutes~~]]; or

20 (3) imprest funds kept by enforcement agencies for the
21 purchase of evidence or other enforcement purposes.

22 SECTION 5.06. Section 411.052(a), Government Code, is
23 amended to read as follows:

24 (a) In this section, "federal prohibited person
25 information" means information that identifies an individual as:

26 (1) a person ordered by a court to receive inpatient
27 mental health services under Chapter 574, Health and Safety Code;

1 (2) a person acquitted in a criminal case by reason of
2 insanity or lack of mental responsibility, regardless of whether
3 the person is ordered by a court to receive inpatient treatment or
4 residential care under Chapter 46C, Code of Criminal Procedure;

5 (3) a person determined to have an intellectual
6 disability [~~mental retardation~~] and committed by a court for
7 long-term placement in a residential care facility under Chapter
8 593, Health and Safety Code;

9 (4) an incapacitated adult individual for whom a court
10 has appointed a guardian of the individual under Title 3, Estates
11 Code, based on the determination that the person lacks the mental
12 capacity to manage the person's affairs; or

13 (5) a person determined to be incompetent to stand
14 trial under Chapter 46B, Code of Criminal Procedure.

15 SECTION 5.07. Section 411.0521(a), Government Code, is
16 amended to read as follows:

17 (a) The clerk of the court shall prepare and forward to the
18 department the information described by Subsection (b) not later
19 than the 30th day after the date the court:

20 (1) orders a person to receive inpatient mental health
21 services under Chapter 574, Health and Safety Code;

22 (2) acquits a person in a criminal case by reason of
23 insanity or lack of mental responsibility, regardless of whether
24 the person is ordered to receive inpatient treatment or residential
25 care under Chapter 46C, Code of Criminal Procedure;

26 (3) commits a person determined to have an
27 intellectual disability [~~mental retardation~~] for long-term

1 placement in a residential care facility under Chapter 593, Health
2 and Safety Code;

3 (4) appoints a guardian of the incapacitated adult
4 individual under Title 3, Estates Code, based on the determination
5 that the person lacks the mental capacity to manage the person's
6 affairs;

7 (5) determines a person is incompetent to stand trial
8 under Chapter 46B, Code of Criminal Procedure; or

9 (6) finds a person is entitled to relief from
10 disabilities under Section 574.088, Health and Safety Code.

11 SECTION 5.08. Sections 411.126(a)(2) and (3), Government
12 Code, are amended to read as follows:

13 (2) "Volunteer" or "volunteer applicant" means a
14 person who will perform one or more of the following services
15 without remuneration:

16 (A) any service performed in a residence;

17 (B) any service that requires the access to or
18 the handling of money or confidential or privileged information; or

19 (C) any service that involves the care of or
20 access to:

21 (i) a child;

22 (ii) an elderly person; or

23 (iii) a person who is mentally incompetent,
24 ~~[mentally retarded,~~ physically disabled, ill, or incapacitated,
25 or who has an intellectual disability.

26 (3) "Employee" or "employee applicant" means a person
27 who will perform one or more of the following services or functions

1 for remuneration:

2 (A) any service performed in a residence;

3 (B) any service that requires the access to or
4 the handling of money or confidential or privileged information; or

5 (C) any service that involves the care of or
6 access to:

7 (i) a child;

8 (ii) an elderly person; or

9 (iii) a person who is mentally incompetent,
10 ~~mentally retarded,~~ physically disabled, ill, or incapacitated,
11 or who has an intellectual disability;

12 (D) coordination or referral of volunteers; or

13 (E) executive administrative responsibilities.

14 SECTION 5.09. Section [495.023\(a\)](#), Government Code, is
15 amended to read as follows:

16 (a) The institutional division shall request proposals and
17 may award one contract to a private vendor or community supervision
18 and corrections department to screen and diagnose, either before or
19 after adjudications of guilt, persons who may be transferred to the

27 person with an intellectual disability [~~mentally ill or mentally~~

1 ~~retarded~~] is discharged from the department under Subsection (b),
2 the child is eligible to receive continuity of care services from
3 the Texas Correctional Office on Offenders with Medical or Mental
4 Impairments under Chapter 614, Health and Safety Code.
