A BILL TO BE ENTITLED

1 AN ACT

2 relating to the sequestration of a jury in a criminal case.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

4 SECTION 1. Article 35.23, Code of Criminal Procedure, is

5 amended to read as follows:

6 Art. 35.23. JURORS MAY SEPARATE. (a) The court may adjourn

7 veniremen to any day of the term. When jurors have been sworn in a

8 felony case, the court may, at its discretion, permit the jurors to

9 separate until the court has given its charge to the jury.

- 10 (b) The court on its own motion may [and on the motion of
- 11 either party shall], after having given its charge to the jury,
- 12 order that the jury not be allowed to separate, after which the jury
- 13 shall be kept together [, and not permitted to separate except to
- 14 the extent of housing female jurors separate and apart from male
- 15 jurers, until a verdict has been rendered or the jury finally
- 16 discharged.
- 17 <u>(c)</u> The court, on the motion of either party requesting that
- 18 the jury not be allowed to separate after the court has given its
- 19 charge to the jury, shall hold a hearing to determine whether good
- 20 cause exists to order that the jury not be allowed to separate. On a
- 21 finding of good cause, the court shall enter an order described by
- 22 Subsection (b). A motion by a party requesting that the jury not be
- 23 allowed to separate must be filed not less than 10 days before the
- 24 date jury selection begins unless the requesting party shows good

- 1 cause exists for filing the motion after that period.
- 2 (d) Any person who makes known to the jury which party made
- 3 the motion not to allow separation of the jury shall be punished for
- 4 contempt of court.
- 5 (e) If [such] jurors ordered not to separate are kept
- 6 overnight, facilities shall be provided for female jurors separate
- 7 and apart from the facilities provided for male jurors.
- 8 (f) In misdemeanor cases the court may, at its discretion,
- 9 permit the jurors to separate at any time before the verdict.
- 10 (g) In any case in which the jury is permitted to separate,
- 11 the court shall first give the jurors proper instructions with
- 12 regard to their conduct as jurors when so separated.
- 13 SECTION 2. The change in law made by this Act applies only
- 14 to a criminal proceeding that commences on or after the effective
- 15 date of this Act. A criminal proceeding that commences before the
- 16 effective date of this Act is governed by the law in effect on the
- 17 date the proceeding commenced, and the former law is continued in
- 18 effect for that purpose.
- 19 SECTION 3. This Act takes effect September 1, 2023.
