- 1 (5) public information technology grants, to help
- 2 public libraries make state, local, and federal government
- 3 information that is accessible through the Internet available to

- 5 (6) competitive grants, to promote innovation by

- 7 and to encourage major resource systems or regional library systems

- SECTION 2. Section 441.138, Government Code, is amended by

- 20 $\underline{(2)}$ [τ] personnel;
- 21 (3) [τ] equipment;
- 22 (4) $[\tau]$ administrative expenses;
- 23 (5) new construction, rehabilitation, or renovation
- 24 of a library or the infrastructure of a library and associated
- 25 expenses; $[\tau]$ and
- 26 (6) financing programs that enrich the services and
- 27 materials offered a community by its public library.

- 1 $\underline{(b-1)}$ State grants may not be used for site acquisition,
- 2 [construction,] acquisition of buildings, or payment of past debts.
- 3 SECTION 3. This Act takes effect September 1, 2023.
