## A BILL TO BE ENTITLED

	AN ACT

- 2 relating to emergency generators or other power sources for nursing
- 3 facilities and assisted living facilities.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter B, Chapter 242, Health and Safety
- 6 Code, is amended by adding Sections 242.053 and 242.054 to read as
- 7 follows:
- 8 Sec. 242.053. EMERGENCY GENERATOR OR OTHER POWER SOURCE.
- 9 (a) Each nursing facility licensed under this chapter shall ensure
- 10 the facility is equipped with an operational emergency generator or
- 11 comparable emergency power source and a sufficient amount of fuel
- 12 to operate the generator or power source for a minimum of 72 hours
- 13 <u>during a power outage in:</u>
- 14 (1) an area in the facility of sufficient size to
- 15 maintain residents safely at all times and that is appropriate for
- 16 resident needs; and
- 17 (2) for a nursing facility that maintains an area in
- 18 the facility with an installed unit locking device as defined by
- 19 commission rule to restrict a resident's ability to exit a unit of
- 20 the facility or the facility, a separately powered area in addition
- 21 to an area described by Subdivision (1).
- (b) An operational emergency generator or comparable
- 23 emergency power source required by Subsection (a) may be powered by
- 24 any type of fuel, including natural gas.

- 1 (c) A nursing facility must comply with Subsection (a) not
- 2 later than September 1, 2024. A nursing facility may request from
- 3 the commission an extension not to exceed one year to comply in good
- 4 faith with Subsection (a). A facility may request not more than two
- 5 additional one-year extensions and must separately request each
- 6 extension. This subsection expires September 1, 2027.
- 7 <u>Sec. 242.054. GENERATOR INSPECTION.</u> In addition to the
- 8 <u>inspections required under Sections 242.043</u> and 242.044, the
- 9 commission shall conduct an annual inspection of each facility's
- 10 <u>emergency generator or other power source required by Section</u>
- 11 242.053. The executive commissioner by rule shall prescribe a
- 12 checklist for an inspection conducted under this section.
- SECTION 2. Subchapter D, Chapter 247, Health and Safety
- 14 Code, is amended by adding Sections 247.073 and 247.074 to read as
- 15 follows:
- Sec. 247.073. EMERGENCY GENERATOR OR OTHER POWER SOURCE.
- 17 (a) Each assisted living facility licensed under this chapter
- 18 shall ensure the facility is equipped with an operational emergency
- 19 generator or comparable emergency power source and a sufficient
- 20 amount of fuel to operate the generator or power source for a
- 21 minimum of 72 hours during a power outage in:
- 22 <u>(1) an area in the facility of sufficient size to</u>
- 23 maintain residents safely at all times and that is appropriate for
- 24 resident needs; and
- 25 (2) for an assisted living facility that maintains an
- 26 area in the facility with an installed unit locking device as
- 27 defined by commission rule to restrict a resident's ability to exit

- 1 a unit of the facility or the facility, a separately powered area in
- 2 addition to an area described by Subdivision (1).
- 3 (b) An operational emergency generator or comparable
- 4 emergency power source required by Subsection (a) may be powered by
- 5 any type of fuel, including natural gas.
- 6 (c) An assisted living facility must comply with Subsection
- 7 (a) not later than September 1, 2024. An assisted living facility
- 8 may request from the commission an extension not to exceed one year
- 9 to comply in good faith with Subsection (a). A facility may request
- 10 not more than two additional one-year extensions and must
- 11 separately request each extension. This subsection expires
- 12 <u>September 1, 2027.</u>
- 13 Sec. 247.074. GENERATOR INSPECTION. In addition to the
- 14 inspections required under Sections 247.023(a) and 247.027, the
- 15 commission shall conduct an annual inspection of each facility's
- 16 <u>emergency generator or other power source required by Section</u>
- 17 247.073. The executive commissioner by rule shall prescribe a
- 18 checklist for an inspection conducted under this section.
- 19 SECTION 3. As soon as practicable after the effective date
- 20 of this Act, the executive commissioner of the Health and Human
- 21 Services Commission shall adopt rules necessary to implement
- 22 Sections 242.053, 242.054, 247.073, and 247.074, Health and Safety
- 23 Code, as added by this Act.
- 24 SECTION 4. This Act takes effect immediately if it receives
- 25 a vote of two-thirds of all the members elected to each house, as
- 26 provided by Section 39, Article III, Texas Constitution. If this
- 27 Act does not receive the vote necessary for immediate effect, this
