A BILL TO BE ENTITLED 1 AN ACT 2 relating to distinctive packaging for opioid prescription drugs. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. This Act shall be known as the Red Cap Opioid 4 5 Safety Act. SECTION 2. Section 481.074(a), Health and Safety Code, is 6 7 amended to read as follows: 8 (a) A pharmacist may not: 9 (1)dispense or deliver a controlled substance or cause a controlled substance to be dispensed or delivered under the 10 pharmacist's direction or supervision except under a valid 11 12 prescription and in the course of professional practice; 13 (2) dispense a controlled substance if the pharmacist 14 knows or should have known that the prescription was issued without a valid patient-practitioner relationship; 15 16 (3) fill a prescription that is not prepared or issued as prescribed by this chapter; 17 18 permit or allow a person who is not a licensed (4) pharmacist or pharmacist intern to dispense, distribute, or in any 19 other manner deliver a controlled substance even if under the 20 21 supervision of a pharmacist, except that after the pharmacist or pharmacist intern has fulfilled his professional and legal 22 23 responsibilities, a nonpharmacist may complete the actual cash or credit transaction and delivery; [or] 24

1 (5) permit the delivery of a controlled substance to 2 any person not known to the pharmacist, the pharmacist intern, or 3 the person authorized by the pharmacist to deliver the controlled 4 substance without first requiring identification of the person 5 taking possession of the controlled substance, except as provided 6 by Subsection (n); or

7 (6) dispense or deliver an opioid not in the 8 distinctive packaging required by board rules adopted under Section 9 <u>481.0761(1)</u>.

10 SECTION 3. Section 481.0761, Health and Safety Code, is 11 amended by adding Subsection (1) to read as follows:

12 (1) The board shall adopt rules requiring that an opioid be 13 dispensed in a bottle with a distinctive red cap or, if the opioid 14 is dispensed in a container other than a bottle, in a container 15 bearing a conspicuous red label.

16 SECTION 4. The Texas State Board of Pharmacy shall adopt the 17 rules required under Section 481.0761(1), Health and Safety Code, 18 as added by this Act, not later than January 1, 2024.

19 SECTION 5. The change in law made by this Act applies only 20 to a prescription for an opioid dispensed on or after March 1, 2024. 21 A prescription dispensed before March 1, 2024, is governed by the 22 law in effect immediately before the effective date of this Act, and 23 the former law is continued in effect for that purpose.

SECTION 6. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this
