- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- 5 SECTION 1. Section 212.009, Local Government Code,
- amended by adding Subsection (a-1) to read as follows: 6
- 7 (a-1) Unless specifically authorized by another law of this
- state, a municipal planning commission or the governing body of the 8
- 9 municipality may not:
- 10 (1) require a person to fulfill any prerequisites or
- conditions or obtain any approvals before the person files a copy of 11
- the plan or plat with the municipal planning commission or 12
- 13 governing body;
- 14 (2) delay the starting date for calculating any
- applicable timeframe under this chapter to approve or disapprove a 15
- 16 plan or plat by not considering the date the plan or plat was filed
- as the starting date; or 17
- 18 (3) refuse to accept, acknowledge, process, or act on
- a filed copy of the plan or plat. 19

- 24 SECTION 3. Section 232.00285, Local Government Code,

- 1 amended by adding Subsection (a-1) to read as follows:
- 2 (a-1) Unless specifically authorized by another law of this
- 3 state, the commissioners court of a county or the court's designee
- 4 may not:
- 5 (1) require a person to submit or obtain approval of
- 6 any documentation or other information or fulfill any other
- 7 prerequisites or conditions before the person submits a plat
- 8 application to the commissioners court or the court's designee;
- 9 (2) delay the starting date for calculating any
- 10 applicable timeframe under this chapter to approve or disapprove
- 11 the plat application by not considering the date the application
- 12 was filed as the starting date; or
- 13 (3) refuse to accept, acknowledge, process, or act on
- 14 a submitted or received plat application.
- SECTION 4. Section 212.009(a-1), Local Government Code, as
- 16 added by this Act, applies only to a plan or plat filed on or after
- 17 the effective date of this Act.
- SECTION 5. Section 232.00285(a-1), Local Government Code,
- 19 as added by this Act, applies only to a plat application submitted
- 20 on or after the effective date of this Act.
- 21 SECTION 6. This Act takes effect September 1, 2023.
