5	whom the data is sought the option to select more than one category

8	(d) The provision of demographic data under this section by
9	an individual is voluntary.
10	(e) Not later than the first anniversary of the date the
11	federal decennial census is published, the commission shall update
12	the subcategories of race or ethnic origin to include only the
13	subcategories with populations larger than 7,500 as published by
14	the United States Census Bureau, except that each category must
15	include at least the six largest subcategories.
16	(f) The executive commissioner shall adopt rules necessary
17	to implement this section.
18	Sec. 531.03161. COLLECTION AND CROSS-TABULATION ANALYSIS
19	OF CERTAIN DATA; PUBLICATION. (a) The commission and each health
20	and human services agency that administers a public benefits
21	program shall collect the following data regarding individuals who
22	receive, or were receiving at the time of the individual's death,
23	benefits under a program:
24	(1) the individual's level of English proficiency; and
25	(2) whether the individual:

8	cause; and
9	(H) had a child who died as an infant.
10	(b) To the extent permitted by federal law and if requested
11	by the commission, a local entity, including a local governmental
12	entity, responsible for providing demographic data to the
13	commission or a health and human services agency in connection with
14	a public benefits program administered by the commission or agency,
15	as applicable, shall report to the commission the data described by
16	Subsection (a) to the extent that data is known or obtainable by the
17	entity.
18	(c) The commission shall prepare a cross-tabulation
19	analysis of the data described by Subsection (a) and the
20	demographic data collected under Section 531.0316, including data
21	related to the race or ethnic origin, sex or gender, and sexual
22	orientation of individuals. The analysis conducted under this
23	subsection must consider subcategories and suboptions.
24	(d) Subject to Subsection (f) and to the extent permitted by
25	federal law, the commission shall make available to the public on
26	its Internet website in an easy-to-read format metric data obtained
27	as the result of the cross-tabulation analysis conducted under this

1	section and organized by the demographic data collected in
2	accordance with Section 531.0316. The metric data published under
3	this section must be organized by category and then by subcategory
4	or suboption, as applicable.
5	(e) The commission shall annually update the metric data
6	published under Subsection (d).
7	(f) The storage and communication of data under this section
8	must comply with existing federal and state privacy laws governing
9	individually identifiable information. Data made available to the
10	public under this section may not identify or allow for the
11	identification of individuals.
12	(g) This section does not prevent a state agency from
13	posting demographic data collected by the agency on the agency's
14	Internet website.
15	(h) The executive commissioner shall adopt rules necessary
16	to implement this section.
17	SECTION 2. Not later than December 1, 2024, the Health and
18	Human Services Commission shall publish on its Internet website the
19	metric data required under Section 531.03161(d), Government Code,
20	as added by this Act.
21	SECTION 3. If before implementing any provision of this Act
22	a state agency determines that a waiver or authorization from a
23	federal agency is necessary for implementation of that provision,
24	the agency affected by the provision shall request the waiver or
25	authorization and may delay implementing that provision until the
26	waiver or authorization is granted.
27	SECTION 4. This Act takes effect September 1, 2023.
