13	(A) located in a county with a population of more
14	than 1.1 million and less than two million; and
15	(B) subject to:
16	(i) a fire code adopted and enforced by a
17	municipality or emergency services district; or
18	(ii) an interlocal agreement between the
19	county and a municipality or emergency services district for the
20	county to not enforce the county fire code.
21	SECTION 2. Subchapter B, Chapter 352, Local Government
22	Code, is amended by adding Section 352.0195 to read as follows:
23	Sec. 352.0195. LIMITED AUTHORITY IN CERTAIN AREAS. (a)
24	This section applies only to an area described by Section
