Sections 2306.5621(b), (c), (d), (f), and (h-1), 16 Government Code, are amended to read as follows: 17 18 (b) The corporation shall establish a program to provide eligible fire fighters, corrections officers, county jailers, 19 public security officers, peace officers, emergency medical 20 services personnel, professional educators, social workers, and 21 veterans with low-interest home mortgage loans. 22 23 (c) To be eligible for a loan under this section, at the time a person files an application for the loan, the person must: 24

(d) The corporation may contract with other agencies of the state or with private entities to determine whether applicants qualify as fire fighters, corrections officers, county jailers, public security officers, peace officers, emergency medical services personnel, professional educators, <u>social workers</u>, or veterans under this section or otherwise to administer all or part of this section.

(5) the verification of occupancy of the home by the fire fighter, corrections officer, county jailer, public security officer, peace officer, professional educator, <u>social worker</u>, veteran, or person defined as emergency medical services personnel as the borrower's principal residence; and

7 (6) the terms of any contract made with any mortgage
8 lender for processing, originating, servicing, or administering

10 (h-1) To fund home mortgage loans for eligible fire fighters, corrections officers, county jailers, public security 11 12 officers, peace officers, emergency medical services personnel, professional educators, social workers, and veterans under this 13 14 section, the corporation may use any proceeds received from the 15 sale of bonds, notes, or other obligations issued under the home loan program provided by this section, regardless of any amendments 16 17 to the eligibility standards for loans made under the program and regardless of when the corporation received the proceeds from those 18 19 bonds, notes, or other obligations issued under the program.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2023.
