- 5 SECTION 1. Sections 411.083(b) and (c), Government Code,

- 10 (2) noncriminal justice agencies authorized by
- 11 federal statute or executive order or by state statute to receive

8 The department may disseminate criminal history record information under Subsection (b)(1) or (8) only for a criminal 9 10 justice purpose. The department may disseminate criminal history record information under Subsection (b)(2) only for a purpose 11 12 specified in the statute or order. The department may disseminate criminal history record information under Subsection (b)(4), (5), 13 14 or (6) only for a purpose approved by the department and only under 15 rules adopted by the department. The department may disseminate criminal history record information under Subsection (b)(7) only to 16 17 the extent necessary for a county or district clerk to perform a duty imposed by law to collect and report criminal court 18 Criminal history record information 19 disposition information. disseminated to a clerk under Subsection (b)(7) may be used by the 20 21 clerk only to ensure that information reported by the clerk to the department is accurate and complete. The dissemination of 22 information to a clerk under Subsection (b)(7) does not affect the 23 24 authority of the clerk to disclose or use information submitted by 25 the clerk to the department. The department may disseminate 26 criminal history record information under Subsection (b)(9) 27 $[\frac{(b)(8)}{(b)}]$ only to the extent necessary for the office of court

- 1 administration to perform a duty imposed by law, including the
- 2 development and maintenance of the public safety report system as
- 3 required by Article 17.021, Code of Criminal Procedure, or to
- 4 compile court statistics or prepare reports. The office of court
- 5 administration may disclose criminal history record information
- 6 obtained from the department under Subsection (b)(9) [(b)(8)]:
- 7 (1) in a public safety report prepared under Article
- 8 17.022, Code of Criminal Procedure; or
- 9 (2) in a statistic compiled by the office or a report
- 10 prepared by the office, but only in a manner that does not identify
- 11 the person who is the subject of the information.
- 12 SECTION 2. This Act takes effect September 1, 2023.
