- 2 SECTION 2. Chapter 1702, Insurance Code, as added by this Act, applies only to an insurance policy, evidence of coverage, 3 4 annuity or other contract, or group benefit plan that is delivered, issued for delivery, or renewed on or after January 1, 2024. A 5 policy, evidence of coverage, annuity or other contract, or group 6 benefit plan delivered, issued for delivery, or renewed before 7 January 1, 2024, is governed by the law as it existed immediately before the effective date of this Act, and that law is continued in effect for that purpose. 10
- 11 SECTION 3. This Act takes effect September 1, 2023.
