- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 251, Election Code, is
- 6 amended by adding Section 251.0017 to read as follows:
- 7 Sec. 251.0017. POLITICAL ADVERTISING RELATED TO
- 8 LEGISLATION. For purposes of Section 251.001(16), a communication
- 9 supporting or opposing legislation filed by a member of the
- 10 legislature is considered political advertising under that
- 11 subdivision if the communication appears to express support or
- 12 opposition of:
- 13 <u>(1)</u> the member; or
- 14 (2) persons who support or oppose the legislation.
- SECTION 2. Section 253.031(a), Election Code, is amended to
- 16 read as follows:
- 17 (a) A candidate may not knowingly accept [a] campaign
- 18 contributions totaling more than \$500 [contribution] or make or
- 19 authorize $[\frac{1}{4}]$ campaign expenditures totaling more than \$500
- 20 [expenditure] at a time when a campaign treasurer appointment for
- 21 the candidate is not in effect.
- SECTION 3. Section 254.031(a), Election Code, is amended to
- 23 read as follows:
- 24 (a) Except as otherwise provided by this chapter, each

1 report filed under this chapter must include:

(1) the amount of political contributions [, other than political contributions described by Subdivision (1-a), from each person that in the aggregate exceed \$50 and that are accepted during the reporting period by the person or committee required to file a report under this chapter, the full name and address of the person

7 making the contributions, and the dates of the contributions;
8 [(1-a) the amount of political contributions from each
9 person that are made electronically and that are accepted during

10 the reporting period by the person or committee required to file a

11 report under this chapter, the full name and address of the person

12 making the contributions, and the dates of the contributions;

(2) the amount of loans that are made during the 13 reporting period for campaign or officeholder purposes to the 14 15 person or committee required to file the report and that in the aggregate exceed \$50, the dates the loans are made, the interest 16 17 rate, the maturity date, the type of collateral for the loans, if any, the full name and address of the person or financial 18 institution making the loans, the full name and address, principal 19 occupation, and name of the employer of each guarantor of the loans, 20 21 the amount of the loans guaranteed by each guarantor, and the aggregate principal amount of all outstanding loans as of the last 22 23 day of the reporting period;

(3) the amount of political expenditures that in the aggregate exceed \$100 and that are made during the reporting period, the full name and address of the persons to whom the expenditures are made, and the dates and purposes of the

- 2 (4) the amount of each payment made during the
- 3 reporting period from a political contribution if the payment is
- 4 not a political expenditure, the full name and address of the person
- 5 to whom the payment is made, and the date and purpose of the
- 6 payment;
- 7 (5) the total amount or a specific listing of the
- 8 political contributions of \$50 or less accepted and the total
- 9 amount or a specific listing of the political expenditures of \$100
- 10 or less made during the reporting period;
- 11 (6) the total amount of all political contributions
- 12 accepted and the total amount of all political expenditures made
- 13 during the reporting period;
- 14 (7) the name of each candidate or officeholder for
- 15 whom [who benefits from] a direct campaign expenditure was made to
- 16 support or oppose during the reporting period by the person or
- 17 committee required to file the report, and the office sought or
- 18 held, excluding a direct campaign expenditure that is made by the
- 19 principal political committee of a political party on behalf of a
- 20 slate of two or more nominees of that party;
- 21 (8) as of the last day of a reporting period for which
- 22 the person is required to file a report, the total amount of
- 23 political contributions accepted, including interest or other
- 24 income on those contributions, maintained in one or more accounts
- 25 in which political contributions are deposited as of the last day of
- 26 the reporting period;
- 27 (9) any credit, interest, rebate, refund,

- 1 reimbursement, or return of a deposit fee resulting from the use of
- 2 a political contribution or an asset purchased with a political
- 3 contribution that is received during the reporting period and the
- 4 amount of which exceeds \$100;
- 5 (10) any proceeds of the sale of an asset purchased
- 6 with a political contribution that is received during the reporting
- 7 period and the amount of which exceeds \$100;
- 8 (11) any investment purchased with a political
- 9 contribution that is received during the reporting period and the
- 10 amount of which exceeds \$100;
- 11 (12) any other gain from a political contribution that
- 12 is received during the reporting period and the amount of which
- 13 exceeds \$100; and
- 14 (13) the full name and address of each person from whom
- 15 an amount described by Subdivision (9), (10), (11), or (12) is
- 16 received, the date the amount is received, and the purpose for which
- 17 the amount is received.
- SECTION 4. Section 305.002(6), Government Code, is amended
- 19 to read as follows:
- 20 (6) "Legislation" means:
- 21 (A) a bill, resolution, amendment, nomination,
- 22 or other matter pending in either house of the legislature,
- 23 including the election of the speaker of the house of
- 24 <u>representatives;</u>
- 25 (B) any matter that is or may be the subject of
- 26 action by either house or by a legislative committee, including the
- 27 introduction, consideration, passage, defeat, approval, or veto of

- 1 the matter; or
- 2 (C) any matter pending in a constitutional
- 3 convention or that may be the subject of action by a constitutional
- 4 convention.
- 5 SECTION 5. Section 571.064(b), Government Code, is amended
- 6 to read as follows:
- 7 (b) If a law administered and enforced by the commission
- 8 sets dollar amounts or categories of amounts as reporting
- 9 thresholds or if the commission sets those amounts, the commission
- 10 [annually] shall decennially adjust those thresholds [upward] to
- 11 the nearest multiple of \$100 [\$10] in accordance with the
- 12 percentage increase for the preceding 10 years [previous year] in
- 13 the Consumer Price Index for Urban Consumers published by the
- 14 Bureau of Labor Statistics of the United States Department of
- 15 Labor.
- SECTION 6. Section 254.036(g), Election Code, is repealed.
- 17 SECTION 7. Section 254.031, Election Code, as amended by
- 18 this Act, applies only to a report that is required to be filed
- 19 under Chapter 254, Election Code, on or after the effective date of
- 20 this Act. A report that is required to be filed under that chapter
- 21 before the effective date of this Act is governed by the law in
- 22 effect on the date the report is required to be filed, and the
- 23 former law is continued in effect for that purpose.
- SECTION 8. The changes in law made by this Act to Section
- 25 571.064(b), Government Code, do not affect an adjustment made by
- 26 the Texas Ethics Commission under that subsection before the
- 27 effective date of this Act. An adjustment made before the effective

- 1 date of this Act is governed by the law in effect when the
- 2 adjustment was made, and the former law is continued in effect for
- 3 that purpose.
- 4 SECTION 9. This Act takes effect September 1, 2023.
