10	during the same hours as those prescribed for the sale of malt
11	beverages under Section 105.05, except that the permittee may not
12	sell wine or vinous liquor containing more than 17 percent alcohol
13	by volume [on a Sunday or] after 10 p.m. on any day.
14	SECTION 2. Section 105.01, Alcoholic Beverage Code, is
15	amended to read as follows:
16	Sec. 105.01. HOURS OF SALE: LIQUOR. $[\frac{(a)}{(a)}]$ Except as
17	provided in Sections 105.02, 105.03, 105.04, 105.08, and 105.091,
18	no person may sell, offer for sale, or deliver any liquor:
